### Town of Tomah Town Board Meeting

- The meeting was called to order at 7:30 pm by Chairman Hanson.
- The clerk's report was read. Randie Johns made a motion to accept the clerk's report. Al Bartels seconded the motion. Motion Carried

- Public Comment Period
  - Betty Stoltenberg asked if anything more has been done on the discussion of appointing versus electing a clerk...nothing more has been done
  - Val Holmes asked if there was a timeline for opening County M for ATV/UTV...The Town has no control over that road, it is up to the county to open it up and put up signs.
- Electrical Inspections
  - Shane Rolff from the City of Tomah was present to explain the change...Oakdale Electric is requiring all new electrical services to be inspected by a state certified electrical inspector instead of a master electrician. Shane Rolff currently does the new service inspections for new construction, but the Town will need to hire someone to do all other inspections. The City of Tomah currently has a contract with Emil Baumgart. The Town will need to have a contract with Mr. Baumgart, most likely on a per job basis, and the City could facilitate payment and application delivery.
  - The board will need to discuss a contract with Emil Baumgart
- Liquor Licenses for Grewal Brothers LLC dba Southside Mobil
  - Grewal Brothers LLC have made application for a Class A Liquor, Class A Beer, Cigarette, and 2 beverage server licenses. There have been no issues found with the application. Randie Johns made a motion to approve the Class A Liquor, Class A Beer, Cigarette, and 2 beverage server licenses. Al Bartels seconded the motion. Motion carried.
- Monroe County Unit of the WTA meeting
  - The next meeting will be held on May 19, 2022, Howard and Al are interested in attending. Howard Hanson made a motion to allow the 2 board members to attend. Randie Johns seconded the motion. Motion carried.
