Monthly Board Meeting

Those Present: Howard Hanson, Randie Johns, Allan Bartels, Teresa Hubert, and Breanne Zarembo.

The meeting was called to order at 7:30 p.m. by Chairman Hanson.

The clerk's report was read. Randie Johns made a motion to accept the clerk's report. Allan Bartels seconded the motion. The motion carried.

The treasurer's report was read. Allan Bartels made a motion to accept the treasurer's report. Randie Johns seconded the motion. The motion carried.

Commercial Electrical Inspector

The State of WI says that all commercial electrical work needs to be inspected, and towns need to decide if they will hire an electrical inspector for all jobs, or if the individual jobs will need to hire an inspector. Shane Rolff from the City of Tomah was supposed to find out more information, but he was unable due to COVID. The options are that we could hire Emil Baumgart to be on retainer and we need to file paperwork, we can let the state hire someone, or the City of Tomah can handle it all. Howard Hanson suggested that we table the topic until we can find out more information. Randie Johns made a motion to table the matter, Allan Bartels seconded the motion. Motion carried.

Garbage Attendant

Vaughn Kuehl was hired to take over Saturday Garbage hours at a rate of \$12/hr. Alan Wagner resigned his position in April. Randie Johns made a motion to approve the hiring of Vaughn Kuehl, Allan Bartels seconded the motion. Motion carried.

Review Town Insurance

The insurance policy was reviewed by the board. No real changes have occurred, and premiums have gone down by \$200.

Open Seal Coat Bids

Scott Construction bid \$19,768.30 for 1 mile of single chip seal with blue granite chips, or \$18,729.60 for 1 mile of single chip seal with red granite chips. Fahrner Construction bid \$22,967.30 for 1 mile of single chip seal with dark granite chips. Allan Bartels made a motion to accept the bid from Scott Construction for blue granite chips for \$19,768.30. Randie Johns seconded the motion. Motion carried.

Scott Construction bid the following for Cold Mix Paver Patching:

- 66-100 \$107.93/ton
- 101-300 \$99.87/ton
- 301-500 \$90.34/ton
- 501 and up \$84.64/ton

Compactor

The compactor was repaired last week. There are still some adjustments that need to be made. New nylon strips, wear strips were put in, and they fixed the gate instead of replacing it.

Voting Machines

Breanne Zaremba signed the agreement to obtain an Insight machine. The only cost will be for programming, and a new battery. The rate was prorated for the rest of the year, it will cost \$200 for the rest of the year.
