- The clerk's report was read. Doug Bauman made a motion to accept the clerks report. John Ollendick seconded the motion. Motion Carried
- The treasurer's report was read. John Ollendick made a motion to accept the treasurers report. Doug Bauman seconded the motion. Motion carried.

• Public Comment Period

- Al Bartels mentioned that he was told that we pay extra for the garbage bags that are thrown in the recycle bin. Vaughn Kuehl has been telling people to dump their recycling out of the bags and throw the bags in a separate bin. Breanne Zaremba will make some phone calls to get details on how we are billed for recycling.
- Ernie Thackeray asked on behalf of another resident whether some low hanging tree limbs on Highland Avenue can be cu
- Todd Zaremba requested that the board take a drive down Hobnail Ave to check on the condition of the potholes on the road and the box culvert. He suggested getting 4 loads of gravel from Gerke Excavating, having it spread on the road, after scraping back current material. He could do the work if necessary.
- Ted Lange mentioned there are a couple of trees down near Lucy Sherwood's driveway on Hockey Ave.

• Review Insurance coverage on Town Buildings

- Currently coverage values are as follows:
 - Town Hall/Municipal Building -- \$337,963
 - Garage -- \$127,096
 - Storage -- \$80,882
 - Salt Shed -- \$118,435
- The Proposal is to increase values to the following:
 - Municipal Building/Garage -- \$425,000 RC
 - Garage -- \$250,000 RC
 - Salt Shed -- \$175,000 RC
 - Add Recycle building \$35,000 RC
 - Add Above Ground Fuel Storage -- \$25,000 RC
- o Increases of \$195,000 in value will increase premiums by approximately \$600.
- Doug Bauman made a motion to increase insurance coverage of building. John
 Ollendick seconded the motion. Motion carried.

Open Seal Coat Bids 8PM

Fahrner Construction sent a bid, but did not include a bid bond. For 1 mile single seal 20 foot wide with dark granite chips, cost would be \$34,846.50.

- Scott Construction sent a bid with all requirements according to the bid specs. For 1 mile single seal 20 foot wide with blue granite chips would be \$28,587 and with red granite chips would be \$27,432.
- Doug Bauman made a motion to accept the bid from Scott Construction for red granite chips for \$27,432/mile. John Ollendick seconded the motion. Motion carried.
