

The Daly Round Membership Application and Agreement

This Membership Application and Agreement (hereinafter the "Agreement") is entered into on this _____ day of _____ 20__ by the applicant for the purpose of applying for Membership in The Daly Round (hereinafter "TDR").

Recitals:

1. MEMBER. For purposes of this Agreement "Member" shall mean the person/persons identified on the TDR "Membership Application and Agreement".
2. INDIVIDUAL MEMBERSHIP – A single individual designated on this agreement.
3. FAMILY MEMBERSHIP – Two individuals with the same mailing address designated on this agreement.
4. DUES:

| Membership Program | Cost per Month |
|---|----------------|
| Single Membership (Monday through Thursday) | \$125 |
| Family Membership (Monday through Thursday) | \$150 |
| Single Membership (Monday through Sunday) | \$195 |
| Family Membership (Monday through Sunday) | \$220 |

By signing this Agreement, you agree to automatic recurring monthly payments on the 1st business day of each month.

5. BENEFIT of MEMBERSHIP – The INDIVIDUAL or FAMILY is entitled to utilize golf bay facilities based on their membership level once per day at TDR, excluding holidays.
6. HOLIDAYS – National/Federal holidays are excluded from this agreement, meaning that if a national or federal holiday falls on a day on that the member would otherwise be entitled to utilize their membership benefits, that day is excluded. Standard rates will apply.
7. ADDITIONAL PLAYERS – at the time of play, additional players are allowed to join an INDIVIDUAL/FAMILY MEMBER at a rate of \$10.00 per person per day
8. ADDITIONAL HOURS – If an INDIVIDUAL or FAMILY member(s) would like to utilize the golf bay facilities outside of the designated membership hours, they will be subject to standard prevailing rates. This will include extending the reservation made during the membership hours as well as new reservations outside of membership hours.
9. DURATION OF PLAY: Limits for duration of use of the golf bay are based on the number of players and are as follows:

| Number of people | Maximum continuous hours per day |
|------------------|----------------------------------|
| 1 | 2 |
| 2 | 3 |
| 3 or more | 4 |

10. ADDITIONAL DISCOUNTS – no additional discounts are given to member(s) in this contract.
11. MEMBER PRESENCE – INDIVIDUAL and FAMILY MEMBERSHIP's need one member present to utilize the golf bay.
12. PREFERENTIAL TREATMENT – no preferential treatment for reservations will be made available to INDIVIDUAL or FAMILY MEMBERSHIP's.
13. CANCELLATION NOTICE OF MEMBERSHIP – Cancellation must be made in person or by email with a 30-day notice.
14. SUBJECT TO CHANGE – With a 30-day notice, TDR may at any time in its sole discretion change the rules and or dues set forth above in this Agreement. Signature by applicant in this Agreement acknowledges and agrees to the terms and conditions contained herein.
