Dear PFRo members,

Welcome to summer, everyone! Our Playball night at the Columbus Clippers will be held Saturday, July 21, 2018. We have provided a flyer on the back of this letter if any of our members would like to attend or send a child to the ballgame this year. See everyone there!

Here are some updates. We now have a time-line for our Health Care transition. First, you will be receiving several mailings from Aon, the company that is assisting OP&F members in this transition. All of these mailings will be co-branded with the Aon logo and the OP&F logo.

Please do not throw these mailings away as the information will assist you in making your choice for insurance coverage in 2019.

The following is a quick look at the time-line that Aon and OP&F have agreed upon to reach the transition goal of January 1, 2019.

June 8-12, 2018

- A transition guide/letter will be mailed to all retired members and actives within 5 years of retirement
- The Aon toll free phone number will become active (M-F 8am to 9pm EST)
- Website and educational videos will be available at **myexchangeconnection.com/OP-F**

Aug. 6-15, 2018

- OP&F Pre-Retirement seminars
- Aon representative attends these seminars

Week of Sept 4, 2018

- Medicare education kits and appointment date/time letters mailed. **Must confirm online or by phone to give Benefits Advisor permission to call**
- Pre-Medicare letters and educational packets mailed for member to log on to Aon's website and begin enrollment process with eHealth.

Sept 10-21, 2018

- OP&F Retiree meetings

- 6 Ohio locations (16 meetings)
- Aon representatives attend and co-present with OP&F

Oct 15/ Dec 7, 2018

- Medicare Open Enrollment
- Appointments begin for members to speak to Aon advisor

Nov 1/Dec 15, 2018

- Pre-Medicare Open Enrollment
- Members can speak to an Aon advisor and log on to review plans

Week of Dec 17, 2018

- HRA/Stipend welcome letters
- Delivered by Aon
- Introduce member to your Spending Account and reimbursement process instructions

Jan 1, 2019

- Medicare supplement and prescription drug coverage begins
- Pre-Medicare medical and prescription drug coverage begins

These dates are all of the important dates of which you need to be aware. The only other date that is important is the appointment date and time that an Aon advisor will be contacting you.

Remember to look for the co-branding on the mailings from Aon DO NOT THROW THESE MAILINGS AWAY!

Note: There are some members who are either under 65 and eligible for early Medicare due to disability, or over 65 and eligible for Medicare, but are enrolled in Part A only, or Part B only. This small group of grandfathered participants must remain on OP&F self-insured health plan and will not transition until July 1, 2019.

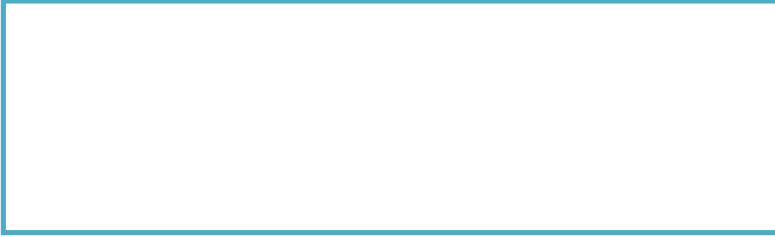
