**CONCLUSION**

In sum, I found the testimony of the Election Division credible regarding the 1,532 signatures found invalid on the basis of the signor of the nomination papers being not registered to vote at all or not registered to vote in the City of Pittsburgh. While Mr. Parker submitted 2,232 signatures and the challengers would only concede approximately 400 valid signatures and raised numerous other signature challenges that remain undetermined, I strike the 1,532 signatures meaning he has 700 remaining signatures. This clearly falls below the requisite number of signatures, 1,168, required by 25 P.S. 2911(b). Reluctantly, because Mr. Parker has failed to present the requisite number of signatures required to be included on the ballot for the November 2021 General Election, the Petition to set Aside his Nomination Papers is granted, and his name is not permitted on the ballot.

ORDER OF COURT

AND NOW, this 26th day of August 2021 upon consideration of Petitioners' Petition to Set Aside the Nomination Paper of William Parker, and the Memorandum Opinion filed in conjunction with this Order, it is ORDERED, ADJUDGED, and DECREED that the Petition is GRANTED. Specifically, it is ORDERED as follow:

1. The Nomination Paper of William Parker is set aside;
2. Candidate Parker does not have a sufficient number of valid signatures to have his name placed on the Ballot in the Municipal General Election to be held on November 2, 2021, as a candidate for Mayor of the City of Pittsburgh;
3. Specifically, as supported by the testimony of the Allegheny County Election Division, while Candidate Parker submitted 2,239 signatures, 1,532 were invalid as the signor was either not registered, or not registered in the City of Pittsburgh. He thus submitted fewer valid signatures than the required 1,168.
4. Petitioners' objections to the Nomination Paper are sustained;
5. The Allegheny County Board of Elections and the Elections Division are directed to strike and set aside the Nomination Paper of William Parker and are further directed to not place his name on the ballot as a candidate for Mayor of the City of Pittsburgh.
