- ✚ This agreement is activated and valid from the date of enrolment until 31 December 2026. (12 months agreement)
- ✚ All dancers that want to do competitions must do the conditioning classes.
- ✚ A student older than 18 years / parent / guardian / sponsor is responsible for the payment of the non-refundable enrolment fee.
- ✚ Fees are listed above and are subject to an annual increase due to rent, inflation, etc.
- ✚ **All fees (monthly or per term) must be paid via EFT before the 7th of each month.**
- ✚ You are required to furnish us with a **proof of payment** via e-mail: truthdanceacademy@gmail.com. Should you fail to comply with the arrangement, it would be assumed that the payment was not made.
- ✚ Fees shall not be reimbursed because of classes not taking place on public holidays and school holidays.
- ✚ Fees shall not be reimbursed should a learner be absent for any reason.
- ✚ In the event of you breaching the payment arrangement and we deem it necessary to engage the services of a registered debt collector to recover any outstanding fees, you shall be liable for:
  - Tracing agent fees
  - Fees, disbursements, and expenses to which the debt collector is entitled in terms of the Debt Collectors Act.
- ✚ Truth Dance Academy will take no responsibility for any injuries that occurs during class, competitions, exam and shows.
- ✚ If you wish to terminate this agreement, you are required to give at least 21 days written notice as per CPA requirements.
- ✚ Truth Dance Academy is not responsible for any Third-Party orders or payments that are made by clients.
- ✚ In the event that the dance instructor cannot teach a class, a notification will be sent, and classes will be rescheduled.
- ✚ A dancer that misses more than 5 classes might not be able to dance in the exams.
- ✚ Ballet / hip hop / modern / tap / jazz classes / acrobatics / contemporary
  - Classes are conducted by a well-trained and qualified instructor.

- Students from the age of 3 are welcome.
  - Classes will be presented in a friendly atmosphere.
- ✚ During the year classes will be presented on the syllabi of the "Dance Academy of South-Africa" (DASA) / Association of International Dance Teachers / WX Hip Hop / Jazz ED / Acrobatic Arts as well as creative open classes.
  - ✚ Grade RR and R pupils will have the opportunity to participate in the external exams of the "Dance Academy of South Africa" and / or internal exams.
  - ✚ Class attire:

    - Bare feet / Trainers for hip hop
    - Hair neatly tied and out of the face
  - ✚ Communication: Because we are busy with classes during the day, the best way to get hold of us is via WhatsApp or contacting admin. You are welcome to send an SMS, WhatsApp or e-mail should you have any other questions or inquiries. We will reply as soon as possible. We are using an administrative system for our emails and SMS's.
  - ✚ By signing this document, you give Truth Dance Academy's qualified teachers permission to touch your child (the student) during their dance class for correcting posture, stance, alignment, movement, strengthening and stretching movements and so forth.
  - ✚ By signing this document, you give Truth Dance Academy permission to post videos or photos of your child (the student) on social media.
  - ✚ Ensure that all payment references correspond with the required monthly fee/ event /item. Truth Dance Academy will not be able to allocate fees correctly if incorrect references are given. The misallocation of fees will result in double invoicing.
