1. Inherent Risks and Assumption of Risk.

The undersigned acknowledges there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of equines to behave inways such as, running, bucking, biting, kicking, shying, stumbling, rearing, falling, or stepping on, that may result in an injury, harm or death to persons on or around them; the unpredictability of equines reaction to such things as sounds, sudden movement, and unfamiliar objects,

persons or other animals; certain hazards such as surface and subsurface conditions, collisions with other animals; the limited availability of emergency medical care; and thepotential of a participant to act in a negligent manner that may contribute to injury to theparticipant or others, such as failing to maintain control over the animal or not acting within such participant's ability.

The rider and/or their guardian acknowledges that horses, by horses very nature is unpredictable and subject to animal whim. Rider assumes all risks in connection therewith, and expressly waives any claims for any injury or loss arising therefrom to FOX LANE FARM/The Riding Academy and its manager, owner, or agents as well as the owners of the real property where FOX LANE FARM/The Riding Academy resides and/or teaches. Rider agrees to abide by and follow all rules and regulations which shall be posted with this liability waiver and available at any time upon request or changes. Rider further acknowledges that the behavior of any animal is contingent to some extent upon the ability of Rider. Rider assumes all risks therefore and warrants a full and fair disclosure of Rider's abilities has been made to Manager.

Rider expressly releases FOX LANE FARM and The Riding Academy and its manager, owner or agents and the real property owners and their guests, family, or agents from any and all claims for personal injury or property damage, even if caused by negligence (if allowed by the laws of the State of Colorado) by the Manager or its representatives, agents or employees according to COLORADO STATE LAW C.R.S. 13-21-119, signage for this lawis posted in highly trafficked areas.

2. Rider agrees to hold harmless, indemnify and defend Manager against, and holdharmless from, all claims, demands, causes of action, damages, judgments,

orders, costs, or expenses, including attorney's fees, whether actually incurred or not, which may in any way arise from or be in any way connected with Rider's use of or presence upon the property of Manager and the facilities located thereon.

- 3. In the event Rider is using Rider's own horse, or a horse(s) not owned by Manager, Rider warrants said horse(s) shall be free from infection, contagious or transmittable. diseases. Manager reserves the right to refuse access or use of any horse upon the premises that does notappear to Manager to be in good health, or is deemed dangerous or undesirable.
- 4. Any accident must be reported directly to Sheila Johnson, the manager/owner of FOX LANE FARM & The Riding Academy within 48 hours of the incident. Any action brought under this agreement shall be brought within three (3) months of the incident or accident giving rise to said claim.

Rider agrees to waive the protection of any applicable statutes in this jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does notknow or suspect to exist at the time of executing said release.

The behaviors of past individuals have shaped these policies, helping to cultivate respect and responsibility in our community.

Thank you for your understanding and cooperation in adhering to these guidelines. Your commitment allows us to maintain the level of service you expect and deserve. We look forward to supporting your growth and success in the saddle!

What to Expect from Your Classes and Instructors

The Riding Academy of GJ LLC accepts students aged 5 and older, depending on instructor availability and class openings. We follow the Montessori Horsemanship & Infinite Core program, which encourages students to progress at their own pace. This approach allows them to build confidence and control while learning essential skills to carry with them throughout their equestrian journey.

Students are expected to care for their assigned horse before and after each class, unless they have purchased the Concierge Lesson Package. This includes tasks such as catching, grooming, tacking up, booting, warming up and cooling down the horse, un-tacking, grooming again, blanketing if needed, and putting away equipment. Depending on the lesson, this can take 45-60 minutes of time outside of the class.

If a student is unfamiliar with any of these tasks, they will be taught these essential horsemanship skills as part of their lessons. Our goal is to foster responsibility and self-reliance in our students, while ensuring that all safety and care protocols are followed.

Please note that while we do not have a specific height or weight limit, we reserve the right to refuse service if a situation presents a risk to the safety or health of our horses. Additionally, we are not currently equipped to accommodate students with special physical or mental needs that require additional resources or equipment. We can provide recommendations for other facilities that cater to these needs.

About the Curriculum & Class Levels

We welcome riders of all ages and experience levels. Our riding programs are based on generations of family tradition in training and horsemanship. Each class is tailored to meet the unique goals of the student, and we incorporate cross-training techniques to help students gain a well-rounded riding experience. For example, English riders will ride Western, and Western riders will ride English to foster versatile horsemanship.

We prioritize teaching our students how to think, problem-solve, and feel the movements of the horse, emphasizing that horsemanship is a skill to be developed, not just a passive experience. We believe that "If you are not training your horse, you are un-training him!" Our lessons begin with English saddles to help students develop an understanding of biomechanics, control, and confidence. However, we believe that the riding discipline is more about mindset and learning, rather than the type of saddle used.

In addition to riding skills, we emphasize foundational horsemanship at every class level. Students will learn how to properly care for their horse, as riding is not just about sitting on a horse, but also about maintaining the horse's well-being and learning how to train and bond with them.

Below is a sample of the basic curriculum lessons you or your student will be accomplishing. This is by no means a comprehensive list of the classes as we run a Montessori style teaching structure, allowing students to move as fast or slow as they wish.

Program Curriculum Samples

1. Basic Lesson Program

- **Definition**: One-on-one lessons focusing on fundamental riding skills, ideal for beginners or those refreshing their riding techniques.
 - Options:
 - **30-Minute Lessons**: Focused and efficient, perfect for quick skill-building.
 - **60-Minute Lessons**: In-depth coaching for intermediate and advanced riders.

2. Skill Builder Program

- **Definition**: Aimed at improving specific skills such as jumping, dressage, or trail riding.
- Options:
- **30-Minute Lessons**: Focused on mastering one technique or movement.
- **60-Minute Lessons**: Comprehensive skill-building with practice and feedback.

3. Tiny Tot/Young Rider Program

- **Definition**: Designed for children or teens, emphasizing confidence, horsemanship, and foundational skills.
 - Options:
 - **30-Minute Lessons**: Tailored for newer or younger riders, with simpler tasks.
 - **60-Minute Lessons**: Suitable for experienced youth, featuring more challenges.

4. Advanced Rider Program

- **Definition**: For experienced riders refining advanced techniques and movements.
- Options:
- **30-Minute Lessons**: Focus on a specific advanced skill or challenge area.
- **60-Minute Lessons**: Comprehensive lessons for advanced skill mastery.

5. Group Lesson Program

- **Definition**: Learn in a group setting with emphasis on teamwork, shared practice, and social interaction.
 - Options:
 - **30-Minute Lessons**: Quick group sessions for basic skills and teamwork.
 - **60-Minute Lessons**: Longer sessions allowing more in-depth skill-building.

6. Rider & Horse Relationship Program

- **Definition**: Focus on rider-horse biomechanics, trust-building, and harmony.
- Options:
- **30-Minute Lessons**: Short sessions to develop rider-horse understanding.
- **60-Minute Lessons**: Deeper focus on relational and physical connection.

7. Equine Groundwork Program

- **Definition**: Develop trust and communication through groundwork exercises.
- Options:
- **30-Minute Lessons**: Basics of groundwork and handling skills.
- **60-Minute Lessons**: Advanced groundwork techniques with varied exercises.

IMPORTANT INFORMATION AND POLICIES FOR STUDENTS AND PARENTS OR GUARDIANS

GENERAL INFORMATION

1. Weather:

Please dress appropriately for the weather. Our outdoor arena is out in the open & offers no protection from the elements.

- You must purchase the "ALL IN" add-on to get all weather lessons.

Extreme weather conditions, or combinations of, that automatically call for canceling/rescheduling lessons for safety purposes.

WIND: (15*) 20 mph or more

LIGHTNING: Any lighting inside 8 miles from the barn

COLD: ANY combo of Temps >30* + < Wind 10mph + Humidity <50% (includes snow/sleet/rain)

HEAT: Actual temperature combined with relative humidity. (Ex., 90* + 70% humidity = 106*unrideable)

RAIN/MUD: Any standing water may cause slick mud resulting in horse classes to be canceled

ANY: Adverse weather making driving conditions too dangerous for getting to class.

2. DRESS CODE:

Riders should always come dressed appropriately and with a willingness to listen and learn from their coach, those who do not will be dismissed from class.

TRAGJ has a Student Library from which new students may "check out" riding gear; Boots, breeches/jodhpurs, helmets, & coats. Students are required to purchase their own equipment within 3-6 months of starting lessons.

Lessons:

- **Top:** An appropriate tucked in shirt

Be conscious of your climate and choose accordingly:

- o Long/short-sleeved sun shirt
- Collared polo style shirt
- o Athletic short-sleeved shirt
- *Technical fabrics will help in warm climates
- **Bottom:** Breeches/Riding pants/Leggings/Jeans
- Accessories: Belt, gloves, safety vest

- Clothing NOT Allowed:

• Tank tops, sleeveless, crop tops, spaghetti straps, tube tops; you will be sent home!!

Additional needed equipment:

We require an eventual purchase within 3 months' time of the equipment listed below:

Helmet: Current (under 5 years old from 1st use) ASTM/SEI helmets are required. Equestrian riding helmets should fit properly and not be too big as to "grow into", or too small to fit overly snug with no give.

- **NOT ALLOWED:** Bicycle, motorbike, or skateboarding helmets.

Riding boots: Hard soled riding boots, or riding shoes are required for riding and working around the barn. English riders should have paddock boots only and western riders may wear paddock boots or western style boots.

- **NOT ALLOWED**: Hiking boots, street shoes, rubber, flat, or slick soles.

Optional Equipment: Half chaps/spats/chaps, weather appropriate riding gloves, safety vest, rain slicker/coat, muck boots/galoshes, class journal.

Equipment NOT Allowed:

- NO open-toed shoes or flip flops will be allowed **around the horses**.

WHEN TO ARRIVE & WHAT'S TO BE EXPECTED OF YOU:

Depending on what lesson options you are purchasing the following requirements will be expected.

Please be courteous and be on time; include your pre-work time if applicable, or unfortunately, your riding class will be short or possibly canceled altogether depending on tardiness. If you are 10 past the time your lesson was supposed to start your lesson will be canceled, with no opportunity for rescheduling.

ALL LESSONS:

- **A. Those capable of readying their own horses** shall arrive a *minimum* of 60 minutes prior to the start of their class to ensure they have time to properly *groom, tack, and warm up their horse* before each class starts and not misuse their class time. It is the rider's responsibility to have their assigned horse ready and prepared. Classes start *at* the appointment time.
 - (FOR THOSE WHO CAN COMPLETE GROUNDWORK: If your lesson time is 100pm then you're expected to show up by 1200 to be on, warmed up, & ready to work by 100pm)
- **B.** Those still learning how to prepare for a lesson should arrive a minimum of 10 minutes prior & will have the guidance of their instructor or class helpers until they are confident/capable enough to be ableto get ready by themselves.
 - (FOR THOSE WHO ARE STILL LEARNING GROUND HORSEMANSHIP: If your lesson time is at 100pm then you are expected to show up by 1250 to be ready to learn at 100pm)

Parental Expectations:

- ** PARENTS: If your child is still a MINOR or a level NOVICE 2 or UNDER, DO NOT JUST DROP YOUR CHILD OFF AND LEAVE! An adult HAS to always be with them until they are under the control of their coach. **
 - Supporting your child in their endeavors and the hard work they need to put into their regular lessons, classes, homework, and health.
 - At TRAGJ/FLF we are deeply dedicated and passionate about our work, dedicating our time and resources to maintaining a professional and high-quality program. While we understand that for many clients, riding is a recreational hobby, we ask for respect towards the financial, emotional, physical, and spiritual dedication and commitment that goes into running this business. Mutal respect ensures a positive and productive experience for everyone involved.
 - -We expect all students, parents, and visitors to respect our coaches and their instruction. Our coaches have invested decades in continuing education, hands-on experience, and significant financial resources to develop the expertise they bring to each lesson. Their knowledge and dedication are the foundation of our programs, and we require that they be treated with the respect they deserve for that.
 - If you have any questions or need clarification on any matter, please do not hesitate to ask. Clear communication regarding rules, policies, training, and all activities with TRAGJ is essential to maintaining a strong and professional working relationship. Our goal is to ensure that students, parents, and coaches have a appositive and fulfilling experience here!
 - We do not respond to communications after hours. Please be sure to know what the current business hours are, as they change seasonally. Generally speaking, they are Tuesday-Saturday 9am-5pm. Leave a message so we know how to return it the next business day. We do not return calls with no voicemail/message.
 - Rules during emergencies regarding a student owned horse are subject to change
 - Your child will be learning all aspects of horsemanship skills as well as riding, this may include unmounted classroom lessons depending on your program. We do have concierge classes for those who do not want or will not complete horsemanship tasks. Your child will automatically be moved to these if they consciously will not complete horsemanship tasks as asked.
 - We encourage you to stay and watch your child respectfully; we provide observation seating & respectfully ask that you remain seated there or in your vehicle.
 - We are always happy when parents would like to help but please ask first!! If the coach or instructor is already helping the student DO NOT jump in to assist! They must learn how to do it on their own! Remember you are paying us to teach them.
 - If you would like to learn with your child, we offer parent classes, so you can have a basic knowledge of what your child is learning.
 - Sideline coaching or talking to your child will not be tolerated. If there is sideline coaching or talking to a child from a parent or guardian, the student will be dismissed from the class. At the end of the class, an appointment will be made with the trainer to discuss the matter.
 - We take safety very seriously!! Absolutely no one under 18 years or a solid Novice 4

is allowed to handle any horse without a coach being on the premises or under control of student and horse, prior permission, or a qualified adult being with the student.

- Parents are <u>required</u> to join the "**REMIND APP**" immediately for all barn communication. Since I do not receive responding communication on most announcements, I will NOT be responsible for anyone not receiving or knowing what's happening at the barn if they have joined the app. If you are not receiving REMIND information, please let me know immediately.

Visitors:

- TRAGJ encourages family and friends to come watch classes.
- Anyone visiting must read and obey our barn rules & sign a liability waiver.
- Visitors under the age of 18 years old must always have an adult with them.
- We ask those here to watch a class please be quiet, and courteous and avoid pointless or extreme movement.
- You are welcome to ask the instructor questions *after* the class has concluded.
- Those who are unable to be courteous and follow our barn rules will be asked to leave and will not be able to return.

MISCELLANEOUS:

1. Students are required to clean up after themselves & the horse they are working with. This is NOT the responsibility of anyone at TRAGJ. Manure, hair, hoof cleanings, and general refuse in the tack room, tacking area, and property, in general, shall be disposed of in the proper areas; these being a muck bucket/garbage can. All necessary tools are conveniently available for any disposal near the arena, barn, and feed areas. There will be a \$5 per incident charge if any items are left for others to clean up for you.

 - Exclusive use of lesson horse, up to 4 weekly practice rides plus lesson time, & ability to show
- c. Horse Board -
 - COST: \$575
 - Basic Full Care Board with 24/7/365 security, security camera, night checks, 40+ years of knowledgeable professional care, & limited emergency watch.
 - Includes standard boarding amenities; 20# quality alfalfa &/or grass hay daily, stall cleaning, minimum of 12+ hrs of turnout, water, limited blanketing, 1 hold for farrier/vet per month/access to arenas & conditioning track, one private tack locker with racks for 1 saddle, 1 bridle, 1 halter, and 2 shelves for storage, small area in feed room for up to 2 bags of Nutrena ProForce/Complete grain & limited supplements.

PAYMENT POLICIES:

- 1. Invoices are sent automatically to you 7 days before the regularly scheduled due date, however, payments not made within 3 days of due date will be charged a \$25 fee and removed from the class schedule until payment is made.
 - a. Students will be removed from the schedule if payments have not been made by the 3rd or the 18th of each month.
 - b. **Tuition Payments are due every month by the 1st or the 15th only, not after, or at your first lesson of the month. This is determined by your sign on date.

- 2. TRAGJ requires a credit card be on file for any tuition payment plans*. Your card will automatically be charged monthly if you are set up for AUTOPAY.
- 3. Discounts are given for payments made by AUTOPAY*, excluding Tuition Program.

- 4. 30 days' WRITTEN notice is required to stop AUTOPAY drafts.

ACCEPTABLE RESCHEDULING POLICY

A make-up class will be rescheduled for classes missed for the following reasons only:

- 1) The class was canceled by the riding instructor. (These are always free & rescheduled at earliest)
- 2) The rider was absent for a health reason, & has an order signed by his/her doctor.
- **3)** There was a death in the rider's immediate family.
- **4)** Pre-announced School activities
- **5)** Extreme weather conditions (These are always rescheduled for free for all)
- **6)** We have preset makeup days & times, see above, if these do not work for you, we will do our best to accommodate but cannot make guarantees. Please understand it is not our responsibility to make room for your makeup schedule as our openings are typically filled regularly.
- **7)** Failure to reschedule your make-up class in a prompt manner with your coach will result in a forfeited class.

2025 BUILT-IN MAKE-UP LESSON DAYS - 3rd Saturday afternoon of each month

Package Program students are allowed 1 FREE reschedule per month, to be taken on one of the preset reschedule days only.

We offer this FREE service to schedule make-up lessons without disrupting regular classes, instructors' schedules, or overworking our horses.

Please see your lesson program for reschedule policies for availability. <u>Should we need to reschedule</u> for any reason only these dates apply for rescheduling. If these dates do not work, please see the head coach and an attempt will be made to help accommodate. We cannot guarantee this will happen.

HOLIDAY AND VACATION DATE CONFLICTS:

If you need to pause your lessons for 14 or more days for any reason but do not want to lose your spot there will be a \$100 per month "Hold Fee" of which 50% is transferable to your first-month package/subscription fee when you return.

We all need time for holidays & vacations. Typically, we always plan on keeping the regularclass schedules except during school vacations, days off, and major holidays, Easter, 4th of July, Thanksgiving, and Christmas/wintertime holidays.

If you cannot attend regular or rescheduled lessons because of a prior commitment for holiday plans or you have planned vacations, please notify your instructor a minimum of 2 weeks prior to your absence to be able to reschedule your classes before leaving.

"Hold fees" Apply for any vacation time of 14 days+.

School Holidays will typically include extra days open for adding lessons, open ride times, or occasionally even makeup lessons, excluding Monday Holidays.

Summer Vacation is always extremely busy for everyone with vacations, summer camps, and horse shows. Please be aware that the schedules are completely different and my move around.

CANCELLATION & PAUSE POLICY*

Lesson Canceling or Pausing Lessons:

Canceling Lessons:

- 1. 30 days' notice should be given to avoid penalties
 - a. 30+ days to due date = FREE
 - b. 15-25 days = 50% Off
 - c. 1-15 days = Full payment
 - d. Failure to pay after 10 days will result in expulsion from the academy permanently.
- 2. Pausing Lessons

If you need to pause your lessons for 14 or more days for any reason but do not want to lose your spot there will be a \$100 per month "Hold Fee" of which 50% is transferable to your first-month package/subscription fee when you return.

REFUNDS

HORSE TACK "Borrowing" (With written permission* only)

Horse tack "borrowing" is meant for short term, like the Student Library equipment, if need to "borrow" for a longer period than 2 months it must be okayed by SHEILA JOHNSON herself by written permission only with an additional fee monthly.

This facility operates under clearly defined rules and policies that have been carefully curated to be as simple and straightforward as possible. While differing opinions may occur regarding these rules and policies, they are not subject to change or be altered based on one's individual preferences or opinions. Compliance with the established policies is mandatory for all parties regardless.

- a) All persons on the TRAGJ/Fox Lane Farm property MUST sign a liability waiver from TRAGJ. Anyone not signing a waiver must remain in the vehicle.
- b) Observe TRAGJ hours. Generally, Tuesday-Saturday 9-5, but change seasonally.
- c) All children under 18 years old must have a parent/guardian signature on the waiver.
- d) Everyone 18 and under must wear a helmet when riding. Children 8 and under must wear a helmet when riding AND working on the ground with horses. Everyone 18 and under must wear a helmet when catching horses in the pastures.
- e) Please leave gates like you found them unless otherwise directed to do so.
- f) Do NOT climb on or over any gate!
- g) No vaping or smoking is permitted in tack room, barn, horse, or lesson areas.
- h) No drugs, marijuana, or alcohol is allowed on property period.
- i) Absolutely NO drama, bad-mouthing anyone, vulgarities, or rude behavior will be tolerated. You will be asked to leave if you or any guests violate this rule.
- j) No one is allowed in the pastures without a coach or a knowledgeable approved assistant.
- k) Absolutely no jumping outside of a lesson.
- NO dogs allowed on the property under any circumstances; not on a leash, left in your vehicle, in our kennels, PERIOD! We have two INTACT male dogs who will fight or breed yours. If you bring dogs, you will be asked to leave. (VESTED SERVICE DOGS ARE ALLOWED WITH PRIOR NOTICE!)
- m) Parking is allowed in designated client parking areas only. Do not block gates, driveway, coaches' home parking area, barn, trucks w/ horse trailers, or arena. If it's wet out, park in front, if it's frozen or dry park in rear.
- n) Safety is extremely important, and we require everyone to always be safe and obey the rules for all involved.
- o) Be hyper aware of your surroundings and watch out for horses, people, dogs, and everything!
- p) Absolutely no one but the student is allowed to handle horses.
- q) Children under the age of 15 must always be under the supervision and control of an adult. If your child acts up or is consistently disobedient in an unsafe manner, they willbe asked to leave.
- r) All riders aged 18 or under MUST always wear an ASTM/SEI-approved helmet when mounted on any horse. Youths 8 years and under must always wear a helmet, in the saddle and on the ground, around horses. Riders over 18 MUST sign a helmet release form if *they choose* not to ride with a helmet! (Parents you may NOT choose if your <18 yo wears a helmet or not, its mandatory, PERIOD)
- s) Do not feed the horses any feed or treats without the express approval or direction of the owner or coach. If permission is granted treats will NOT be hand fed but deposited into a bucket or feeder for horses to eat them.
- t) Any visitors or family members accompanying a rider during a class must remain quietand well-behaved during the class and while at the stable. There is a viewing area for visitors to sit in and quietly observe the class to allow the rider to focus on their ridingsession. Anyone who is being disrespectful or disruptive will be asked to

- sit in their vehicle or leave.
- u) Riders/handlers are expected to clean up after the horse they are working with. This is NOT the responsibility of anyone at SSH. Manure, hair, hoof cleanings, and general refuse in the barn aisle, arenas, wash areas, or around the barn shall be disposed of in the proper areas; these being a muck bucket/garbage can. All necessary tools are conveniently available for this disposal near the arena, barn, and feed areas. There will be a \$5 per incident charge if any items are left for others to clean up for you.
- 1) All general human garbage shall be disposed of in general trash containers only.
- v) Neither The Riding Academy nor Fox Lane Farm, its owners or representatives, nor the legal property owner, their heirs or representatives, will not be held liable for any injury, death, sickness, disease, theft, loss or mutation of personal property, horse, or rider. The client assumes all risks connected with conducting business at the stable and using the facilities as allowed.
- m) Horse turnout and free lunging are allowed in specific areas/times only. Please ask to lunge if other riders(s)/handler(s) are working in the same area.
- n) Hand-walked horses may be allowed to graze in designated areas.
- o) Please do not leave horses unattended in any area, including saddling paddocks, arenas, or work areas.
- p) Classes/lessons take precedence to pleasure riders/boarders. We have plenty or riding space on the property to not be disrupting others paid riding time.
- q) No running around ANY horses!
- r) Please always use courtesy, respect, and common sense around the barn.
