## COW WORK SCORING GUIDELINES

**75 & higher:** Total control. Excellent form and position on animal, high degree of difficulty, excellent eye appeal.

**73-74:** Good form and position on animal, good control of animal, high degree of difficulty with good eye appeal.

**71-72:** A credit earning run with correct form and position, better than average control of difficulty and eye appeal.

**70:** Control. Correct form, average degree of difficulty.

**68-69:** Slight loss of form or position on animal. Average degree of difficulty and eye appeal. Good work with a major penalty (3 or 5) or average work with 1 point penalties.

**66-67:** Trouble controlling animal and/or rider/horse is out of position. Loss of eye appeal.

**65 & below:** Incurs major penalties, loss of control and position. Total lack of credit.

**-0- SCORE:** Failure of an exhibitor to attempt to complete the work; Abuse; Lameness
