

CRAZY TRAIN PRODUCTIONS: 2019 CAJUN CAN CHASE SHOW RULES

SWEEPSTAKES:

1. Final entry deadline: 6PM on December 14th with \$30 late fee
2. Deadline for changes: 6PM on December 14th
3. Final Draw will be posted by 6:45PM on December 14th

CAJUN-ROO BARRELS:

1. You can pre-enter by mail (post mark deadline November 15th) or enter onsite beginning at 8AM on December 14th with late fee. Cash ONLY on site!
2. Final entry deadline: Books will close for late entries 11AM December 14th with a \$10 late fee per rider per day or \$15 for weekend if at time of entry.
3. Deadline for changes: 11AM December 14th.

OPEN BARRELS:

1. You can enter onsite beginning at 8AM on December 14th with late fee. Cash ONLY on site!
2. Final entry deadline: Books will close at last 50 runners with a \$10 late fee per rider per day or \$15 for weekend if at time of entry.
3. Deadline for changes: Start time of each race of the open.

GENERAL RULES:

1. No spaghetti straps, tank tops, etc. Heels down boots and jeans required. Hats and helmets optional.
2. No horse numbering is required.
3. If a horse is run out of order, it will be disqualified.
4. There will be an arena judge at all times. Judges' decisions are final.
5. There will be a drag after every 5 numbers and a big drag after every 50.
6. Contestants must be ready when called. Failure to be in position in the holding area will result in a disqualification. Contestants must be in holding pen during your drag.
7. Reruns will be given only in the event of a time malfunction. If a rerun is given, it will be up to the judge and the contestant to decide when the rerun will take place. Reruns will not be given for contestant equipment breaking or for a rider's decision to pull up.
8. Contestants MUST maintain forward motion once in the alley way. Turning around will result in a disqualification.
9. All pets must be kept on leashes at all times.
10. If a contestant's barrels or timers are misplaced, that contestant will be given a rerun at the conclusion of the round.
11. Crazy Train Productions reserves the right to create any new rule, or modify any existing rule, in order to better the sport or this barrel race.
12. Crazy Train Productions reserves the right to refuse entry for any reason.
13. If any contestants' times are tied, the prize money will be split equally. We will flip a coin to determine who wins prizes.
14. Prizes will be mailed at the expense of the winner.
15. To receive your winnings, a completed W-9 must be submitted at check in or payout will be delayed or even forfeited.

PAYOUTS AND AWARDS:

1. Sweepstakes, Open Barrels, and Cajun-Roo winnings will be paid to the rider. A W-9 must be on file for the rider in order for checks to be released.
2. Awards not picked up on site will be mailed at the recipient's expense.
3. Checks must be deposited within 60 days of receipt.

REFUNDS:

1. No refunds after December 1, 2019.

CAJUN-ROO 5D BARRELS:

1. \$500 Added 5D Barrel Race open to riders 13 years and younger at the time of race.
2. Format: 5D with ½ second splits
3. Entry Fee: \$35 per entry.
4. Payout: 100% of added money, 75% of entry fees, progressive payout
5. Pre-entry draw will be posted on December 10th.
6. Enter on site until with \$10 late fee per rider per day or \$15 for weekend if at time of entry. Books close for late entries at the last 50th rider.
7. Changes must be made in the show office by 11AM December 14th.

SWEEPSTAKES:

1. Sweepstakes is a non-divisional race where the fastest horse(s) receive payout/winnings/prizes.
2. Any horse/rider may enter and there is no limit to the number of horses a rider may enter.
3. 80% payback of entry fees, 100% of added money. \$2,000 added.
4. Will pay 1 place per 10 riders up to 7 places. See payout scale below for specifics.
5. Sweepstakes entry deadlines: November 25, 2019 for pre-entry draw. Enter with \$30 late fee until 6PM on December 14, 2019.
6. No refunds will be given for any reason after December 1st.
7. No entry that has not been paid in full will be allowed to run.
8. You can opt to carry your sweepstakes time over to the Saturday Open Race for an additional \$40 entry fee. Each horse may compete a maximum of four times in the Open (including carry overs).
9. Final entry deadline: 6pm on December 14th with \$30 late fee
10. Deadline for changes: 6pm on December 14th
11. Final Draw will be posted by 6:45PM on December 14th

1. \$3,000 Added each day (Saturday, December 14th & Sunday, December 15th)
2. Format: 5D with ½ second splits
3. Entry Fee: \$40 per entry per day.
4. Payout: 100% of added money, 75% of entry fees, progressive payout
5. Pre-entry draw will be posted on December 10th.
6. Enter on site until with \$10 late fee per rider per day or \$15 for weekend if at time of entry. Books close for late entries at the last 50th rider.
7. Changes must be made in the show office prior to the start time of the open.

FACILITIES:

1. Hook ups and stalls are available, but limited. Contact the Lamar Dixon Expo Center 225-450-1009 to reserve.
2. Vendor booths are the only outlets where merchandise/services may be sold. All other retail transactions are strictly prohibited. Vendor space may be reserved with completion of vendor form and \$60 reservation fee.
3. Crazy Train Productions and Lamar Dixon Expo are expressly released and discharged from any and all liabilities, loss, injury or damage to persons or property. Attendees must adhere to all guidelines of both Crazy Train Productions and Lamar Dixon Expo. No exceptions will be made.
