Rules and Regulations

Setup & Parking

- Vendors must arrive and be fully set up **before 9:00 AM**.
- Vendor vehicles must park in **designated vendor parking areas**, away from attendee traffic.
- Parking locations will be communicated prior to the festival.

Space Allocation

- Each vendor will receive a **designated setup area**.
- Spaces are assigned solely to the Business listed in this contract.
- Location requests are **not guaranteed**.
- Standard space size is approximately **12 ft x 12 ft**, unless otherwise specified.

Pack-In / Pack-Out Policy

- Vendors must provide their own trash bags.
- All trash generated at the vendor space must be removed by the vendor.
- Vendors are responsible for maintaining a clean, trash-free area.
- Periodic trash pickup will be provided throughout the day.

Breakdown Time

- The festival concludes at **5:00 PM**.
- For attendee safety, vendors should remain set up until foot traffic allows safe removal of tents and equipment.

Right to Remove
