PIHA, JCHL – Junior Club Hockey League, Rink Hockey (1 tournament per month at SC rinks), Artistic event, Year end Speed event,

Roller Derby will not yet be sanctioned through NRS.

Board appreciates all efforts from Sherry Rodaway in lead up and through event.

All coaches were certified.

NRS membership total went from estimated 420 to over 500.

No egregious complaints from consumers, athletes, event attendees – only questions.

CJ Yoder introduces topic of 'Weekend Warrior' event registration. Board determines it's a subject matter for another time.

#### 6. Other Business:

Topics discussed include upcoming 2023 Pan Am Games (Rink Hockey). This is a World Skate initiative. Jim Jost reminds board members that Rink Hockey is not part of the Pan Am Games, while Artistic and Speed Skating are a part of the Pan Am Games in Santiago, Chile.

- Erib Gaber brings up topic of NRS administering tests for Artistic Roller Skating
- Conversation shifts to certification process across all roller sports: NRS coaches, referees, etc., and how to implement such certification process.
