- VII. Treasurer's Report by Chris Brookes
 - Low expenses in past 2 months

 - Rich L. volunteers to go to next SRHS Operations Meeting to explain funding situation and procedure to teachers so they understand the process and we can get a better sense of needs before budget meeting for next year.
