FACILITY GUIDELINES:

- A 50% NON-REFUNDABLE DEPOSIT IS DUE TO RESERVE YOUR EVENT. THE REMAINING BALANCE WILL BE DUE ON OR BEFORE THE FIRST DAY OF THE SCHEDULED EVENT.
- THE INDIVIDUAL LISTED ABOVE MUST BE AT THE FACILITY DURING THE ENTIRE TIME OF RENTAL
- GYM AND EQUIPMENT WILL BE USED ONLY FOR ITS INTENDED ACTIVITIES
- RENTER MUST PROVIDE PROOF OF LIABILITY INSURANCE FOR SPONSORING ORGANIZATION AND PERSONAL INSURANCE FOR ALL PARTICIPANTS.
- ALL OUTSIDE INSTRUCTORS/COACHES MUST PROVIDE PROOF OF LIABILITY INSURANCE AND HAVE CLEARED A CURRENT (NON-EXPIRED) BACKGROUND CHECK.
- NO ONE IS ALLOWED ON ANY EQUIPMENT WITHOUT A COACH.
- PARENTS, SIBLINGS, AND/OR SPECTATORS ARE NOT ALLOWED IN THE GYM AREA.
- WATER IS ALLOWED IN THE GYM, PROVIDED IT IS IN A SEALABLE CONTAINER WITH A LID.
- ALL FOOD OR DRINKS ARE TO BE KEPT AND CONSUMED OUT OF THE GYM (LOBBY AREA ONLY).
- GUM IS NOT ALLOWED ANYWHERE IN THE GYM.
- LOTION, BODY SPRAYS, HAIRSPRAY, AND OTHER PERSONAL HYGIENE PRODUCTS SHOULD BE USED IN THE RESTROOMS AND NOT IN THE GYM OR LOBBY.
- WE ASK THAT SMALL CHILDREN ARE SUPERVISED BY ADULTS AT ALL TIMES, AND ARE NOT ALLOWED TO RUN THROUGHOUT THE FACILITY.
