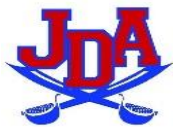

- I. Once an account becomes more than 45 days past due, grades will be held until account is brought up to date, and extracurricular activities including athletics will be suspended.
- J. Once an account is more than 60 days past due, the student will no longer be allowed to attend classes until the account is current.
- K. In order to maintain order and efficiency within our bookkeeping at JDA, we sometimes ask that separate checks be written for items such as, but not limited to, tuition, lunch fees, athletic fees & purchases, fundraisers, and field trips.
- L. There is an Athletic Fee of \$200.00 per student athlete. Parents of each athlete are required to participate in the athletic program during that sport season. There are many opportunities in which to help the program, such as concessions, cleanup before and after games, etc. Non-participation in these programs that enhance our athletic department results in a \$400 fee per sport played that is assessed through the tuition program at the end of each athletic season.
- M. Currently enrolled families paying tuition in full on or before August 1, 2023, will receive a 5% discount. Newly-enrolled families paying tuition in full on or before the first day of classes of the 2023-2024 academic school year will receive a 5% discount.

\_\_\_\_\_ I understand that each new student, along with those returning students that do not have the following items on file will be REQUIRED to provide them within 14 days after enrollment.

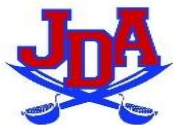
