Notes and Conditions for R.O.S.E.T. Awards

1. Applications should, wherever possible, be submitted by the Head of School, Youth Organisation, Club or Employer and not the candidate's parent. Candidates seeking funds from several sources for a major project may apply themselves providing full sponsorship details with a confidential letter are submitted.
2. Candidates of either sex must normally be between 15 and 25 years of age. However in exceptional cases applicants will be considered outside this age range.
3. Candidates must live, work or attend a place of education within the area of the Rotary Club of Sidcup (A2 to A20, Eltham to Footscray). This condition will be strictly adhered to as it is the basis on which the Trust was founded.
4. Confidential comments of the supporting or sponsoring person are of particular importance and must be supplied in all cases. The main objective of the scheme is to provide a challenge and experience for young people who might otherwise not have such an opportunity. The fact that the person is likely to benefit from a challenging course is unlikely, in itself, to be adequate justification unless it can be shown that there are additional factors to support the candidate's selection. These would include the financial, family and social circumstances of the candidate.
5. Young people who are handicapped will be considered subject to agreement with the organisation running the course or project. Please submit appropriate details explaining the candidate's disability.
6. The Trustees reserve the right to refuse any application without giving reasons for their decision which shall be deemed final.
7. Successful applicants will be expected to submit, after the event, a brief statement as to its success or otherwise and how they have benefited personally. If the event is cancelled or the applicant is unable to attend, a full refund of the bursary will be expected.
8. The ROSET award scheme is operated by the Rotary Club of Sidcup on behalf of the Trustees of this registered Educational Trust. The capital to finance the scheme was contributed by members, their friends, local firms and organisations as part of their voluntary support of the local community.
