2025 ROCKING CASH STALLION BREEDING CONTRACT

GENERAL TERMS:

1. RUNNING RIVER RANCH, LLC (RRR) hereby reserves one breeding to ROCKING CASH, AQHA Registration #5991779/APHA Registration #01116173, (6 PANEL: N/N, Lethal White Overo: N/N) for the Mare _____, Registration # _____, for the Breeding Fee of \$2,000.00, plus Chute Fees and shipping fees (Breeding, Chute Fees and shipping fees are payable to RRR) during the 2025 breeding season, February 1 to July 15th.

Shipping fees are actual Fed EX rates to your designated location for the date requested. A shipping fee may be required for each individual shipment.

Because ROCKING CASH will continue to show throughout 2025, frozen semen will be available for this breeding contract, unless the horse is available for collection and arrangements are made for delivery of fresh cooled semen.

2. SEMEN WILL NOT BE SHIPPED UNTIL THE BREEDING FEE IS PAID IN FULL, A SIGNED CONTRACT, AND A COPY OF THE MARE'S REGISTRATION PAPERS ARE RECEIVED BY RRR.

3. This contract is non-transferable and is not assignable without prior written consent from RRR. Contracts paid in full but not utilized will be cancelled and refunded after July 15th.

4. If the above-named Stallion should die or become unfit for service and there is not any frozen semen available for use, or if the mare should die or become unfit to breed, this contract shall become null and void, and any money paid as part of this service (except Chute Fees and shipping fees) shall be refunded.

5. Owner must attach a copy of the mare's registration papers (front and back) to this contract and provide all other information as requested. The Owner agrees to breed the mare specified in the contract. If a mare change/substitution is needed and a copy of new mare's registration papers are received by RRR, the first substitution is free of charge. Each additional substitution will have a \$150 management fee unless extenuating circumstances apply. An additional breeding fee of \$1,000 will be charged

for inseminating any other mare without notifying RRR first of the change, breeding a mare multiple times without the matching number of paid contracts prior to breeding, or breeding any mare without a current paid, new or re-breed contract in place.

6. Should any foal born to the mare pursuant to this contract, not stand and nurse, the Owner shall be entitled to a re-breed during the following season. THIS RE-BREED SHALL APPLY ONLY IF RRR IS NOTIFIED WITHIN ONE (1) WEEK OF THE DEATH OF THE FOAL. THIS NOTIFICATION MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN, STATING THE CAUSE OF DEATH. The Owner shall pay Chute Fees and shipping fees for re-breeding, under the same terms set forth in this contract for the following breeding season. If re-breeding is not attempted in the following breeding season the contract will be voided.

7. Should the mare's Owner successfully flush an embryo from the mare, this contract is fulfilled. If there is a negative flush, the Owner is entitled to a second or third dose if required as described in this contract, dependent upon semen availability.

8. This contract provides for one (1) Breeder's Certificate. If multiple embryos are retrieved from conventional embryo transfer, an additional management fee of \$300 for each embryo will be assessed. It will be the responsibility of the mare's Owner to notify RRR of the number of embryos transferred. If multiple embryos are desired and more than one breeding is required, an additional contract is required for each breeding.

9. If the mare Owner desires to freeze embryos, it will be the mare Owner's responsibility to pay all nomination fees. It is also the mare Owner's responsibility to notify RRR when the embryo(s) is frozen and when utilized. If not reported by November 1st, the mare Owner will be responsible for all late fees (currently \$100 per embryo). If ICSI procedure is used to produce multiple embryos, additional Embryo Fees will be paid as follows: Advertised breeding fee of year each embryo is utilized plus a management fee of \$300 each (all fees are due when the recipient mare has a positive 60-day pregnancy check).

10. TO OBTAIN A "BREEDER'S CERTIFICATE" YOU MUST NOTIFY RRR OF THE BIRTH OF THE FOAL. CERTIFICATE WILL NOT BE ISSUED IF THE ACCOUNT HAS NOT BEEN PAID IN FULL. THE STALLION OWNER IS RESPONSIBLE FOR SIGNING THE BREEDER'S CERTIFICATE.

11. In the event of any injury or death to the mare and/or foal, the mare Owner will look solely to his/her own insurance. In the event anyone assesses a cause of action against the Stallion Owner on account of injury or death to the mare and/or foal, RRR shall be held harmless from any such cause of action including cost of defending same.

12. If it should be necessary for RRR to retain the services of an attorney to enforce its rights under the terms of this contract, including but not limited to the collection of any

sums due, the mare Owner will pay RRR all expenses and costs, including reasonable and necessary attorney's fees incurred by RRR in enforcing this contract.

13. Any dispute related to this contract will be governed by the laws of the State of Nevada and venue of any dispute arising from this Contract shall be in Douglas County, Nevada.

14. All mare Owners must pay breeding, dose, management, late and embryo fees with US Funds via Wire Transfer (\$50 surcharge) or check from a US bank account.

15. If the stallion leaves RRR ownership in the middle of the breeding season, RRR will forward a copy of all contracts and records needed to the new stallion owner, which will thus terminate all mare Owner's breeding contracts with RRR.

SHIPPED SEMEN:

1. ALL CONTRACTS, REGISTRATION AND OTHER DOCUMENTATION REQUESTED MUST BE RECEIVED BY RRR 72 HOURS PRIOR TO ORDERING SEMEN.

2. Mare Owners are strongly encouraged to order semen early and prior to peak season. We will ship FROZEN SEMEN to your veterinarian for storage, so semen is available when your mare is ready to breed. FRESH SEMEN will be shipped as available.

3. All shipments must be ordered BY TELEPHONE (916)716-8343 by 11 am (PST), THE DAY BEFORE the shipment is to be sent. Semen will be sent on a "first to order" basis. Mare Owner should expect to receive one dose of semen.

Semen order cancellations must be made by 8 am on the shipping morning or a processing fee of \$100 will be charged.

4. A second dose, and third dose, if necessary, are subject to a \$250 dose fee plus actual shipping fees for a re-ship. If an additional dose is required, Owner must provide a written statement from a veterinarian that the mare is reproductively sound to continue shipping.

5. The Breeding Fees as specified above must be paid prior to the first shipment of semen.

6. Semen shipments require a valid credit card on file.

7. ALL SEMEN SHIPPING CONTAINERS MUST BE RETURNED CLEAN AND WITH ALL PARTS. A tracking number for return shipping on the shipping container is required. Return labels are included with shipment. Shipping container must be returned at the mare Owner's expense within 5 days of receipt of shipment. If the container is
