- **ACT FAST** because many stains and damage issues are time-sensitive ... so is your plan. You must call to report your claim within 30 days of when the stain or damage occurred.
- **CALL US AT 800.253.3957 to file a claim.** Have your receipt and plan number handy.

ACCIDENTAL DAMAGE** such as

- cigarette burn
- scissors cut or puncture
- separated seam
- ballpoint pen ink
- rip or tear
- broken zipper or button
- mechanism failure
