### AN INAUGURAL YEAR

Episcopal Lutheran Alliance is the 501c3 non-profit, tax-exempt, charitable organization of the Historic Church of the Holy Cross. Formally the "Homewood Neighborhood Development Association," ELA was renamed in 2018 and embarked on reforming the organization with a revolutionary vision of uniting two of the largest faith bodies in the city — The Episcopal Diocese of Pittsburgh and the Southwestern Pennsylvania Synod of the Evangelical Lutheran Church in America, into an entity with the purpose of initiating community outreach efforts together.

The mission of ELA is to establish collaboration critical to community redevelopment – that what is done on the front-in is critically important to sustaining communities in the long term. By working directly with the community, a pathway is laid out for substantial buy-in by the entire neighborhood, restoring civil confidence between the community and enterprise – everyone benefiting from their investment. We provide programs, resource mobilization, and community organizing that help strengthen, empower, and advance advancing the concerns of the under-served communities in the Pittsburgh/Homewood community.

A New Hope for Homewood – Since my appointment as the President and CEO of ELA, we have engaged in many community outreach initiatives to bring to light and advance the community spirit of Homewood and to capture the social justice ideas fostered in partnership with the Historic Church of Holy Cross.
