PRELIMINARY FINANCIAL REPORT TO THE HOMEOWNERS ON THE STATUS OF THE ENCLAVE AT BERWICK PLANTATION HOMEOWNERS ASSOCIATION, INC.

Introduction

In arriving at the point for the Board of Directors to publish this preliminary report, we have spent in excess of forty (40) hours combing over financial information, invoices, billings, contracts, accounting reports, having conversations with vendors, and most especially, obtaining information from our property management company, Association Services (herein after "Associa"). We stress that this narrative is preliminary in nature and will change as more information is discovered. This is true as we learn more from our investigation and obtain advice from our Finance Committee and others.

Again, we welcome anyone, including former Board members, to provide any information that might be helpful in aiding the present Board with arriving at answers to our financial status. Unfortunately, up to this juncture we have had little communication from the former Board with information helpful to making a smooth transition.

As members of the Board, past and present, we were given authority to act on behalf of the homeowners. Therefore, we have a fiduciary duty as corporate officers to protect corporate property, most importantly, monies belonging to the The Enclave at Berwick Plantation Homeowners Association, Inc. (hereinafter "HOA"). The failure to exercise a reasonable degree of responsibility may place liability on the one holding such fiduciary position. (Citations omitted). Included in the category as a fiduciary would be the property management company, Board members, etc.

We are having difficulty obtaining copies of the former Board's vote approving operating expenses, if any. The failure to record approval of payments, whether approved by the HOA or Associa, is a failure of the Board's fiduciary duties as discussed above. In addition, we do not have recorded anywhere written approval from the Board for the transfer of monies from the reserve funds to our operating account if that is a proper way to transfer reserve funds. We have it on good authority, **unconfirmed at this juncture**, transfer of funds from reserve to operating account is unlawful at worst, or improper at best, if not approved by the

homeowner members.¹ We will seek more guidance and law supporting this important issue. More on our reserve fund below.

HOA Financial Record Discussion With Limited Examples

Reserve Funds Account

Prior to the election, we were informed that the Reserve Fund was \$440,000.00. At our first comprehensive meeting with Associa representatives, the reserve fund was reported to be \$412,000.00. That was on January 18, 2024. In an updated email from Associa dated January 25, 2024, we were informed of a mistake in the reserve fund calculations which brought the fund down to \$309,829.21. Even with this updated amount, we still have no documentation the former Board voted on moving money from the reserve fund to the operating fund or that the issue was presented to the homeowners. (The email from Rebekah Johnson with Associa dated January 25, 2024, is attached as Exhibit "A").

As everyone can imagine, repaying this reserved fund is going to be a monumental task. The present Board is of the opinion it is mandatory to reimburse the reserve fund to cover unexpected maintenance and repairs. For example, sealing and re-paving our streets, major repairs to our clubhouse, storm water drainage issues,² water leaks as we experienced this past year with our pool, etc.

ADT Alarm System

As another example of billing questions, we have attached a copy of an ADT alarm billing from July to August 2023. The first thing you will notice is the address for the top billing is 1 Enclave Lane. We believe that is the gatehouse address, or at least we are reasonably sure at the writing of this update the service for that bill should be the gatehouse. Also, you will notice the billing is in arrears in multiple places. Delinquent payment of bills adds costs to the regularly scheduled billings and seems to be a common occurrence with the former Board and/or Associa. At the writing of this report, we do not have a total of late fees for 2023 billings but we expect the amount to be considerable.

¹ A community association manager we have consulted with unrelated to Associa has indicated the transfer of funds obtained from the settlement of a lawsuit against the Berwick Property Owners Association (hereinafter "POA") could not be transferred without homeowners approval.

² The Berwick POA has shared responsibility for supporting drainage systems and there was a lawsuit settlement in favor of The Enclave for \$600,000.00. We are unsure where this money was spent and for what reason since we are of the opinion these funds were to be used exclusively for storm water drainage.

On Saturday January 27, 2024, we discovered a billing for 110 Blue Moon Crossing. The charges were from Heat Low Voltage for fire alarm inspection \$300, sprinkler inspection \$535, and fire alarm monitor \$744 at the Blue Moon Crossing address. That address is in or near Savannah Quarters subdivision off Pooler Parkway. Again, this is an error at least or fraud at worst.

Inspection of the clubhouse leaves one perplexed with the number of cameras found on the premises. There are two (2) sets of cameras at identical locations. One set being ADT and the other Technology Solutions. (See the ADT billings attached as Exhibit "B").

The Technology Solutions cameras were paid for in 2022 through an outright purchase. There are no monitoring or monthly fees and all Technology Solutions' cameras are working.

We are unsure of the status of the ADT cameras. We pay a monthly fee for alarm system monitoring through ADT, if activated. Of course, it is a duplication of services to have two (2) sets of cameras outside the building from two (2) separate vendors. Ten cameras inside the clubhouse are working. It is unclear to the present Board why the ADT cameras were purchased or leased. We have no record of a vote approving the purchase or lease from ADT and no explanation for the purchase. We believe the ADT cameras were installed in April 2023. (See the ADT billing attached as Exhibit "B").

Conclusion

We have discovered many purchases during the last year without a record of approval by the Board. Regardless, billings were paid by Associa on their own initiative absent the proper authorization, with many being late as referenced above. It is unclear to us at present why Associa thought acting without Board approval was proper. So far, Associa has been unable to supply authority for their actions. We have requested such documentation on several occasions.

Unfortunately, some contracts we may be stuck with after Associa's acting on its own initiative by signing contracts, however, there is a bright light on occasion. For example, on Thursday January 25, 2024, we were able to renegotiate our pool contract at a fair savings. This will enable us to open the pool earlier than expected. We are hopeful it will open by March 5, 2024, rather than

April 1, 2024, as we expected at first. In addition, it will remain open until October 31, 2024. Therefore, the pool will be open for eight (8) months each year.

We hasten to point out it has been a mere thirty (30) days since this Board has been in office. More information will follow as we have information to report. Finally, we have worked many hours to reduce our budget by a considerable amount and are optimistic we can find more savings as we gain a better understanding of the proposed budget for 2024. So far, we have discovered the former Board's budget for 2024 was substantially underfunded when compared to 2023 spending and we continue to build a revised 2024 budget, work on finding savings, re-negotiating contracts, and dropping services when the opportunity presents itself.
