The organization also has an internal procedure which it uses to monitor and assess potential risks in the region and grantee project. If a grant is approved, the parties then enter into an international grant agreement to govern the use of the grant funds by the grantee. The agreement requires grantee to maintain the funds in a segregated account and sets forth the specific projects to be conducted in accordance with Section 501(c)(3). Following execution of the agreement, the grantee is required to submit regular financial and program reporting (quarterly and annual) with photos and supporting documentation which is reviewed by the board. ICRC works to conduct yearly site visits to monitor the progress and use of the grant funds by grantee and also continually reviews and researches grantee organizations in accordance with anti-terrorism recommendations by the US Treasury.
