### THE EXHIBITOR UNDERSTANDS AND AGREES AS FOLLOWS:

1. Chase Con Expo LLC hereafter known as "OWNER" and will determine the assignment of space. Renter of space will be known as EXHIBITOR and Saratoga Comic Con as EVENT. Special requests will be accommodated when possible.
  2. Upon receipt of EXHIBITOR'S application and payment, OWNER will assign space on a first come, first serve basis depending on your product. If EXHIBITOR is denied space, upon OWNER'S return of payment, neither party shall have any further rights or obligations of liabilities with regard to the other.
  3. Load on Friday 7/10/26 12pm-7:30pm & Saturday 7/11/26 6:00am-9:30am. Load out on Sunday 7/12/26 4pm-8pm. Business is to be conducted until closing on 7/11/26 9:30am-6pm and 7/12/26 930am-4pm. If you need to leave early please inform OWNER. Aisles must be kept clear for safe access during the event. No extra tables to be brought in unless permission is given by the OWNER. No table(s) may be shared with another business.
  4. Booth purchases come with 1 6' table, 2 chairs per table, 2 tickets per booth. Any additional weekend tickets will be \$30 extra. Contact [alliet.chaseconexpo@gmail.com](mailto:alliet.chaseconexpo@gmail.com) for more info.
  5. No distribution of other cons or events at the EVENT unless given permission prior. Anyone caught doing this will be asked to leave with no reimbursement.
  6. EXHIBITOR will comply with all local, state and federal laws including the collection of sales tax of NY.
  7. OWNER reserves the right to make such additional rules as deemed necessary and EXHIBITOR agrees to such rules and their interpretation by OWNER..OWNER also has the right to deny certain items sold.
  8. Items sold that are not listed below may lead OWNER to ask you to take items out of the Event or you may be asked to leave entirely, with no reimbursement. No items for tobacco, drugs, sexualized items, ai art are to be sold at the Event.
  9. EVENT/OWNER and agents, officers and employees thereof, shall not be liable for property damage or personal injury to EXHIBITOR or agents and employees thereof, which may occur on or about the subject premises, regardless of how such injury or damage may have occurred. EXHIBITOR waives any claim against Chase Con Con Expo LLC and assumes all liability for loss or damage to EXHIBITOR'S property entrusted to the premises. EXHIBITOR shall hold OWNER harmless and shall indemnify OWNER against all liability or expenses arising out of any claim of injury or damage to any person or property, together with all costs in connection with the defense thereto including attorney's fees. OWNER requests EXHIBITOR to have their own insurance.
  10. If EVENT is canceled by OWNER for any reason, OWNER'S sole responsibility to EXHIBITOR is to return any payments paid by EXHIBITOR, and neither parties shall have any further rights, obligations or liabilities to each other.
- OWNER has the rights to postpone the EVENT in case of a natural disaster or state regulated cancellations, and move EXHIBITOR'S payment and saved spot to that EVENT'S new dates. A postponement is not a "canceled event".
11. No refunds due to weather, absenteeism or any other reason, besides what is written in section 10 above.

PayPal or credit card additional surcharges and processing fees will be added into the bill, no acceptions. **DO NOT SEND US MONEY THROUGH PAYPAL.** We will refund you back only the amount we received and not the paypal charges. You need to wait for us to send the PayPal invoice for you to pay with all the surcharges added in. Also without payment, your form is not valid. This is also a first come first serve basis.
