THE CLIENT'S RESPONSIBILITY

- Images must be original images of the actual item/s submitted for sale. Please do not provide images of similar items, or of items from other websites.
- The client is responsible to submit an accurate description of the condition of items submitted for sale. Any blemishes, flaws, imperfections or repairs must be communicated to SB SOS in writing.
 - If a sale fails to proceed because the Client knowingly did not disclose or document an item's flaw, SB SOS is entitled to receive 50% of the item list price from the Client.
 - Include dimensions and any information you have about the provenance of the item's, it's history, serial number, maker or brand name etc.
- Items will remain in the client's possession until sold. Client's will provide SB SOS access to collect the item/s within 48 hours of the sale.
 - Storage of items by SB SOS is an additional fee.
 - Let us know in advance about access issues e.g. steps, elevators, time limitations etc.

SB SOS LLC IS RESPONSIBLE FOR

- Securing images for items to be sold/ auctioned, additional research and promotional description.

- SB SOS will list items on their online store and or auctions, and use their marketing lists and promotional platforms to promote items for sale.
 - SB SOS has the exclusive right to sell items for a period of 120 days (renewable if mutually agreed to).
 - SB SOS reserves the right to select items that they will list and sell, and to remove an item from sale at any time.
- SB SOS does not guarantee the sale of any item or guarantee the amount of revenue the contents of a Lot may bring. Any presentation of item prices or earnings is an estimate only.
 - If necessary, SB SOS will determine items in a Lot. SB SOS reserves the right to change the items in a Lot at any time.
- SB SOS will determine minimum price, bidding increments and price reductions, unless otherwise agreed upon (in writing) with the Client.
 - If the Client sets reserve prices on items, and the items don't sell, or are removed from sale by the Client, then SB SOS is entitled to a 50% commission of the reserve price.
- Delivery/ pick-up: SB SOS will coordinate the logistics of delivery to the buyer. In most circumstances, the costs of shipping or delivery are covered by the buyer, unless otherwise agreed to by the client.
- Client earnings are usually payable by SB SOS LLC within 10 business days (if items were auctioned, there may be a third party processing delay of up to 30 days).
- Client earning structure for each item sold is as follows unless otherwise negotiated in writing-

Item Sale	Client Earnings
\$0 - \$1,000	50%
\$1,001 - \$10,000	65%
\$10,000 +	65%/ negotiable

By signing your name below, you agree that you are the owner, or legally able to contract with SB SOS LLC for the sale of items submitted to SB SOS LLC.

If any dispute, or claim arising from the work by SB SOS LLC, its employees and agents can not be resolved directly with the Client within 30 days, then the dispute shall be submitted to a non-binding mediation conference in the City of Santa Barbara, CA.
