	Ashley Stone reviewed financial statements from September 2023. The daycare		
	brought in \$7000 in fundraising. The expenses were at \$2000, including Supercash		
	raffle. There were higher wages for staff, though lower wage topups. The bank		
	account made \$5.99 in interest. There was a mortgage payment of \$2274.55		
	towards the principal, with \$3762.61 in interest. There was an overall loss of \$6000		
	this month and a \$20,000 surplus in the quarter.

Reports	a. Daycare Report Gayle MacDonald presented the daycare report to the board.
	As of November 1 <sup>st</sup> , the preschool started, along with the Infant 2 and OSC 3 rooms. Infant 2 will be full next month.
	There have been no new hires and McKenzie will be leaving at the end of December. Fatima will go on a month long holiday and Adel will be gone for 7 weeks starting the middle of Februrary. She completed her level 3. Taylor has gone back to Grand Prairie and could possibly be back for the summer.
	First Aid training has been booked and it was a large expensive. Ten educators will participate and the training will be at the pool. There were a lot of materials bought for the new rooms. There has been discussion for new rules for funding and Gayle is looking into facility funding. The next educators meeting will be on the 20 <sup>th</sup> and 21 <sup>st</sup> of this month. There is currently a Town of Peace River grant for renovations which will be sent out by a parent who works for the Town, though pictures of the previous kitchen cannot be found.
	The daycare is still on the hunt for a shed. Instead of buying one, perhaps one would be built by one of the high school students or by a daycare family. Supplies would be purchased by the daycare and whomever its built by would be granted volunteers hours.
