



LIFE COACHING AGREEMENT

The following represents a Contract between **Invictus Development Group, LLC** and _____, known as the “Client”. Dylan Sessler is identified as the “Coach” from Invictus Development Group, LLC. The Coach and the Client are known as “the Parties”.

Purpose of Agreement

The Services contracted shall be that of life coaching, as set out below (Invictus Development Group, LLC). The purpose of this Agreement is to develop a coaching relationship between the parties in order to cultivate the Client’s personal goals and create a plan to carry out those goals through stimulating and creative interactions with the ultimate result of maximizing the Client’s personal potential (“**Life Coaching Services**”). Please read this agreement carefully and raise any questions or concerns that you have with the Coach before agreeing to the contract. This agreement will begin upon acceptance by Client and shall remain valid for the duration of the Client-Coach relationship.

Services

Life coaching services provided by Invictus Development Group, LLC are typically conducted virtually via Zoom or via telephone. Coaching is a partnership focused on developing the client’s awareness, thinking, and abilities in order to help the client overcome obstacles and identify and achieve goals. In coaching conversations, the Coach will be direct and honest and encourages the Client to do the same. The success of the coaching engagement depends upon the Client’s commitment and openness to the process. If the Client believes that coaching is not working as desired, the Client agrees to communicate this to the Coach.

Confidentiality

Invictus Development Group, LLC fully protects the privacy and confidentiality of the communications with its Clients. No notes are kept during meetings unless specifically requested by the Client. At no time will Invictus Development Group, LLC voluntarily divulge the coaching relationship between themselves and their Clients without written permission from the Clients, unless required to do so by law.

Coach-Client Relationship – Duties & Responsibilities

A life coaching relationship is a partnership between two or more individuals or entities. This relationship is not a legal partnership, instead more like a teacher-student or coach-athlete relationship. Each party must uphold their obligations for the coaching relationship to be successful. Client agrees to communicate honestly, be open to feedback and suggestions, and to fully engage and devote himself/herself to the coaching process. Client acknowledges and agrees that coaching is a comprehensive process that may explore different areas of their life but it is ultimately the Client’s decision how they incorporate coaching into each aspect of life. Client is solely responsible for implementing the techniques discovered through coaching but also not required to implement something the Client is not comfortable with. Coaching is simply coaching. Goals and actions recommended are educated suggested, not legal requirements.

Coaching Schedule

The Client agrees to schedule life coaching sessions with the Coach using the online scheduling system, Calendly, on www.DylanSessler.com. It is of the Client's discretion regarding length and frequency of sessions as well as responsibility of booking sessions with Coach.

Coaching Fees

In exchange for coaching services, Client agrees to pay Coach the agreed upon fee when scheduling a session. Coaching fees are paid in advance of sessions via online through PayPal.

Cancellations

Giving 24 hours' notice for cancellations is ideal. If the Coach needs to cancel, every effort will be made to reschedule a session in a timely manner. If Client does not cancel in a timely manner on a regular basis, the coaching relationship may have to be terminated.

Termination of Services

Not all Coach-Client relationships will work. Either Party may terminate services immediately upon written or verbal notice for various reasons.

Limited Liability

Coach makes no guarantees, representations or warranties of any kind or nature, express or implied with respect to the coaching services negotiated, agreed upon and rendered. In no event shall the Coach be liable to the Client for any indirect, consequential or special damages. Notwithstanding any damages that the Client may incur, the Coach's entire liability under this Agreement, and the Client's exclusive remedy, shall be limited to the amount actually paid by the Client to the Coach under this Agreement for all coaching services rendered through and including the termination date. Client agrees that the Coach is not liable or responsible for any actions or inactions, or for any direct or indirect result of any services provided by the Coach.

Applicable Law

This Agreement shall be governed and construed in accordance with the laws of the state where both Parties reside, without giving effect to any conflicts of laws provisions. If the Parties reside in different states, this Agreement shall be governed and construed in accordance with the laws of the State of Wisconsin, without giving effect to any conflicts of laws provisions.

Entire Agreement

This Contract constitutes the entire agreement between the Client and the Life Coach and the Life Coach shall not be held responsible and shall remain blameless for any adverse or other consequences, including but not limited to financial, personal, employment or other losses, arising out of decisions or actions the Client may make as a result of the Services provided by the Life Coach.

The Parties agree to the terms and conditions set forth above as demonstrated by having an initial life coaching session and all sessions thereafter. It is applied that the Client has read and agrees to the Agreement when the Client schedules a session with Coach on www.dylansessler.com.
