Your child may also have a makeup application with the use of eyeshadow, blush and/or lipgloss, face masks, facial lotions, glitter tattoo with the use of body glue and color sparkles.

I Acknowledge that there are certain risks involved in participating in the party, in addition to the usual risks and dangers inherent in any physical activity, including without limitation allergic reactions, slips, falls, or as a result of physical contact with another person. I warrant that I have notified the hosting Parent of any allergies that I, or my child, or any of the guests of the party may have. I acknowledge that while Party Divas On The Go will make efforts to accommodate any requests for alternate products, Party Divas On The Go shall not be held responsible for any allergic reactions to any of the products used at the party or of any food/ pastries/ drinks provided by us. I am aware that I can provide an alternative to any makeup or skin care item that I would prefer my child to use at the party if they have sensitive skin, etc. Or my child can opt out of using any product that we provide.
