9 It is expressly agreed by Owner and Kat's Kennels LLC that Kat's Kennels LLC liability in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$200.00, whichever is less.
10 Owner agrees to release, indemnify, and hold harmless Kat's Kennels LLC from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Kat's Kennels' LLC services, except which may arise from the gross negligence or intentional and willful misconduct of Kat's Kennels LLC, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Kat's Kennels LLC (ii) your dog or cat, including but not limited to destruction of property, dog or cat bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.
11 Owner warrants and represents that Owner's pet is not a "show dog" or "show cat" and does not participate in dog shows or cat shows. Owner further represents that Owner generates no revenue or income fron the pet's performance. Owner does not intend, plan or anticipate that its pet will generate revenue or income in the future.
12 This Agreement shall be governed by and construed in accordance with the laws of the State of Virginia. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the State of Virginia. Owner and Kat's Kennels LLC must negotiate and mediate in good faith prior to either party filing a cause of action
13 Force Majeure. Neither Owner nor Kat's Kennels LLC shall be responsible for failure or delay in performin its duties under this Agreement if such failure or delay is due to tornados, thunderstorms, fire, floods, drought, riot, war or other acts of nature.
14 Words "you" and "your" refers to the Owner. Conversely, "We" and "our" refers to Kat's Kennels LLC. Owner and Kat's Kennels LLC may collectively be referred to as "the parties", and singularly as a "party".
15 Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns c

#### Waiver of Liability and Assumption of Risk Agreement Use of Premises

Waiver: In consideration of my use of the premises of <a href="Kat's Kennels LLC">Kat's Kennels LLC</a>, I for myself, my heirs, personal representative or assigns, do hereby release, waive, discharge, and covenant not to sue <a href="Kat's Kennels LLC">Kat's Kennels LLC</a>, it's trustees, directors, officers, employees and agents from liability from any and all claims including negligence of myself \_\_\_\_\_\_ and/or my pet \_\_\_\_\_\_ resulting in persona injury, accidents, or illnesses (including death) and property loss arising from use of premises.

Assumption of Risk: **Boarding, Daycare, Grooming, and/or Training** carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I have read the previous paragraphs and I know and understand and appreciate these and other risks are inherent in the activity I am participating in. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to indemnify and hold harmless **Kat's Kennels LLC**, its trustees, directors, officers, employees and agents from any and all claims, actions, suits, costs, expenses, damages and liabilities including attorney fees as a result of this use of premises.

Severability: The undersigned further expressly agrees that the forgoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the State of Virginia and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgement of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, and fully understand its terms. I acknowledge that I am signing the agreement freely and voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

Health or Medical Problems & Senior Pets: Grooming procedures can sometimes be stressful, especially for a senior pet or pet with health problems and can expose hidden medical problems or aggravate a current one during or after the groom. In the best interest of your pet this contract/agreement will give Kat's Kennels permission to obtain immediate Veterinary treatment for your pet should it be deemed necessary by Kat's Kennels. We will do our best to contact you first, then take your pet to your authorized Veterinarian, or to the nearest Veterinarian that is available. It is agreed that all expenses for Veterinary care will be covered by the pet's owner upon signing this contract/agreement.

**Fleas/Ticks:** Kat's Kennels strives to be a flea/tick-free kennel. We do not offer chemical flea or tick dips or sprays. If your pet has a heavy flea or tick infection, we will ask that you reschedule your grooming appointment once the flea or tick problem is under control. Pets with a flea or tick infestation carry a risk of anemia, infections, tapeworms and other health problems. We recommend that you contact your

veterinarian for advice on the best treatment for your situation. A topical monthly flea preventative, such as Frontline, Advantage etc. may be the most effective choice. Treating all pets in the family, as well as treating your home and yard will help in keeping fleas and ticks under control for the long term, and pets and family comfortable & healthy.

Matted Coats: Pets with severely matted coats need extra attention. Mats in a pet's coat grow tight, and can strangle the pet's skin, or eventually tear it open. Kat's Kennels will not cause serious or undue stress to your pet by removal. Mats can be very difficult to remove and may require the pet to be shaved. When necessary, removing a heavily matted coat includes risks of nicks, cuts or abrasions due to warts, moles or skin folds trapped in the mats. Heavy matting can also trap moisture and urine near the pet's skin allowing mold, fungus or bacteria to grow, causing skin irritations that existed prior to the grooming process. Torn skin from mats can even harbor maggots. After effects of mat removal procedures can include itchiness, skin redness, self-inflicted irritations or abrasions and failure of the hair to regrow. Shaved pets are also prone to sunburn and should either have sunscreen applied daily or should be kept out of the sun until the hair grows sufficiently to protect the skin. In some case pets may also exhibit brief behavioral changes. Prevention is the best defense against matting by scheduling regular grooming appointments. If your pet needs to be shaved to remove matting, by signed below you acknowledge that you agree to this procedure, and any risk.

Hematoma of the ears as the ear(s) will feel different with removal of matted fur and may cause vigorously shaking of the head.
