Kat's Kennels LLC Boarding Policies & Legal Stuff

*** Please Read and Initial Each Section ***

1. ___ Kat's Kennels LLC reserves the right to immediately change your pet's type of boarding or daycare if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff, and Owner agrees to pay any additional costs associated with the change.

2. ___ Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from your vet before starting daycare or boarding.

3. ___ Owner agrees that the pet shall not leave the kennel until all charges are paid in full to Kat's Kennels LLC.

4. ___ Owner agrees to be solely responsible for any and all acts or behavior of Owner's pet while it is in the care of Kat's Kennels LLC.

5. ___ Owner specifically represents that they are the lawful and valid owner of the pet, free and clear of all liens and encumbrances.

6. ___ Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.

7. ___ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, Kat's Kennels LLC may exercise its lawful rights upon fourteen (14) days written notice by delivering such notice via first-class mail to Owner's Address. A pet that is unclaimed at Kat's Kennels LLC for fourteen (14) days beyond its scheduled discharge date is considered abandoned and will become the property of Kat's Kennels LLC. Every effort will be made to contact Owner if abandonment becomes an issue. If for any reason the pet is not going to be picked up on the scheduled dismissal date, Owner shall contact Kat's Kennels LLC to make arrangements to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.

*** Please Read and Initial Each Section ***

8. ____ If the pet becomes ill or if the state of the animal's health otherwise requires attention, Kat's Kennels LLC at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$500.00. If a veterinarian determines that emergency treatment, which Exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal.

9. ____ It is expressly agreed by Owner and Kat's Kennels LLC that Kat's Kennels LLC liability in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$200.00, whichever is less.

10. ____ Owner agrees to release, indemnify, and hold harmless Kat's Kennels LLC from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Kat's Kennels' LLC services, except which may arise from the gross negligence or intentional and willful misconduct of Kat's Kennels LLC, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Kat's Kennels LLC (ii) your dog or cat, including but not limited to destruction of property, dog or cat bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

11. ____ Owner warrants and represents that Owner's pet is not a "show dog" or "show cat" and does not participate in dog shows or cat shows. Owner further represents that Owner generates no revenue or income from the pet's performance. Owner does not intend, plan or anticipate that its pet will generate revenue or income in the future.

12. ____ This Agreement shall be governed by and construed in accordance with the laws of the State of Virginia. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the State of Virginia. Owner and Kat's Kennels LLC must negotiate and mediate in good faith prior to either party filing a cause of action.

13. ____ Force Majeure. Neither Owner nor Kat's Kennels LLC shall be responsible for failure or delay in performing its duties under this Agreement if such failure or delay is due to tornados, thunderstorms, fire, floods, drought, riot, war or other acts of nature.

14. ____ Words "you" and "your" refers to the Owner. Conversely, "We" and "our" refers to Kat's Kennels LLC. Owner and Kat's Kennels LLC may collectively be referred to as "the parties", and singularly as a "party".

15. ____ Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of Owner and Kat's Kennels LLC.

Waiver of Liability and Assumption of Risk Agreement Use of Premises

Waiver: In consideration of my use of the premises of **Kat's Kennels LLC**, I for myself, my heirs, personal representative or assigns, do hereby release, waive, discharge, and covenant not to sue **Kat's Kennels LLC**, its trustees, directors, officers, employees and agents from liability from any and all claims including negligence of myself _____ and/or my pet _____ resulting in personal injury, accidents, or illnesses (including death) and property loss arising from use of premises.

Assumption of Risk: **Boarding, Daycare, Grooming, and/or Training** carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I have read the previous paragraphs and I know and understand and appreciate these and other risks are inherent in the activity I am participating in. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to indemnify and hold harmless **Kat's Kennels LLC**, its trustees, directors, officers, employees and agents from any and all claims, actions, suits, costs, expenses, damages and liabilities including attorney fees as a result of this use of premises.

Severability: The undersigned further expressly agrees that the forgoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the State of Virginia and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgement of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, and fully understand its terms. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

I understand that attendance of a pet obedience training class is not without risk to myself, members of my family or guests who may attend, or my pet, because some of the pets to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care.

In consideration of and as inducement to the acceptance of my application for training membership in this training class, I hereby agree to indemnify and hold harmless Kat's Kennels, its subcontractor, owners and agents from any and all claims, or claims by any member of my family or any other person accompanying me to any training session or function of Kat's Kennels, or while on the grounds or the surrounding area there to as a result of any action by any pet, including my own.
