Colombia Localization Terminology

The following table defines the terms used in NetSuite to support Colombia-specific business processes:

Self-withholding	Self-withholding at source consists of the liable taxpayers subject to withholding. The value corresponding to the respective withholding fee is self-withheld. Therefore, in those cases, the taxpayer acts as a withholding agent and at the same time as the liable taxpayer subject to withholding at source.
	Withholding at the source product of self-withholding must be recorded both as a liability and as an asset. The reason for this is because the self-withholder generates a withholding payable and a withholding receivable that can be discounted from the withheld tax.
CUFE	Código Único de Facturación Electrónica. The Unique Electronic Invoicing Code used to unequivocally identify electronic invoices in Colombia.
DIAN	The objective of special administrative unit Dirección de Impuestos y Aduanas Nacionales (DIAN) is to help guarantee the tax security of the Colombian State and the Protection of the national public economic order, through the administration and control of tax obligations proper compliance.
Support Document	It is the document used to confirm the purchase of a product or service, and that the buyer must generate when doing transactions with a vendor who is not obligated to issue a sales invoice or an equivalent document.
ICA	ICA is the Industry and Commerce Tax, which generates conducting industrial activities directly or indirectly, commercial or services, developed permanently or occasionally, in a given property, whether there is a commercial establishment or not.
Magnetic Media Information	The magnetic media information corresponds to the wholesomeness of data that individuals and legal entities must present before DIAN, regarding their transactions and operations involving third parties.
VAT	The general sales tax, commonly known as Value-Added Tax (VAT) is a tax corresponding to product and service consumption and gambling and games of chance. It is tax of national order, indirect, in rem, of instant taxability and general regime.
Tarriff Code	It is a 10–digit numeric code, through which a determined product can be identified anywhere in the world. The Harmonizes System (HS) established a common numeric and text system, which allows for the classification of products commercialized internationally.
Individual	Individuals can be understood as the human being who wants to perform and practice obligations personally, taking into account the way in which their company constitutes. Therefore, they assume all the obligations that may be presented to them in the future.



Legal Entity	It is a society formed by one or more people, capable of practicing rights and acquiring obligations, which can be represented judicially or extrajudicially. This means that the legal entity can be represented by one or many individuals or legal persons. The legal capacity is used to give recognition to this abstract person, who will be given a name in order to be identified as a legally constituted company. Therefore, said society can assume obligations and acquire necessary responsibilities to be able to develop or carry out an economic activity.
Withholding at Source	It is a mechanism applied in the acquisition of products and services in order to pay income tax and supplemental taxes in advances.
RUT	The taxpayer unique register (RUT) constitutes the unique mechanism to identify, locate and classify the people and entities who are liable taxpayers of income tax and non-liable taxpayers of income and patrimony, those responsible for general tax regime, those who are part of the simplified tax regime, withholding agents, importers, exporters and other customs users, as well as other subjects of obligations administrated by DIAN.
Third Party	Any individual or legal entity with whom the company establishes a commercial relationship, whether they are a customer, vendor or similar.
UVT	Tax Value Unit. It is a value measure that allows for the adjustment of the values in the dispositions related to taxes and obligations administrated by the National Directorate of Taxes and customs (DIAN).

Setting Up Colombia-specific Preferences

In NetSuite, set up your company and personal user preferences that are specific to doing business in Colombia.

Colombia-specific Company Preferences

Make sure that your NetSuite role has the appropriate permissions to enable features and set up company preferences specific to Colombia.

To set up Colombia-specific Company Preferences:

- 1. In NetSuite, go to Setup > Company > Set Up Tasks > Enable Features.
- On the Company subtab of the Enable Features page, under ERP General, check the Multiple
 Units of Measure box if you want to define multiple units for the purchase and sale of inventory
 items.:
- 3. Under International:
 - a. Check the **Multi-language** box if you want to use NetSuite in more than one language.
 - b. Check the **Multiple Currencies** box if you want to use NetSuite for multiple currencies.
- 4. On the **Analytics** subtab of the **Enable Features** page, check the **SuiteAnalytics Workbook** box.
- 5. Click Save.
- 6. NetSuite provides predefined Colombian states and provinces. To add custom states and provinces, go to Setup > Company > Set Up Tasks > States/Provinces/Countries and filter the country Colombia. For more information, see Setting Up States, Provinces, and Countries (only available in English)
- 7. Go to Setup > Company > Classification > Subsidiary
- 8. Enter your company information and do the following:
 - In the Tax Responsibilities field, select the obligations that appear on the company's RUT issued by DIAN.



- b. In the **Tax Regime** field, select whether or not you are liable for the sales tax VAT.
- c. In the **Third-Party** field, designate the company's name.
- d. In the **Verification Digit** field, it is calculated pursuant to the formula established by DIAN.
- e. In the **Tax Scheme** field, select the fee identifier corresponding to the company.
- f. In the **Invoicing Email** field, select the email through which your customers can reply to the electronic invoice sent.
- g. In the **Legal Company Name** field, select the name as it appears on the RUT issued by DIAN.
- h. In the **Country** field, select Colombia.
- i. In the Country/State/Province field, select one of the provinces personalized or provided by the system.
- j. In the Currency field, select the name of the currency used in Colombia with the ISO currency code "COP" associated.
- k. In the Address tab, enter the company's business address registered on RUT issued by
- I. In the **Tax Registers** tab, introduce the company's country, link, tax, agency and TIN.
- m. In the **Logo** field, include the logo images that you want to appear on the PDFs generated by the module.
- 9. Click Save.
- **Note:** The Tax Responsibilities, Tax Regime, Tax Scheme and Verification Digit Fields are used for electronic invoicing. Please be aware that these values should meet the values assigned by DIAN to the company's TIN.
- **(i) Note:** The Third Party entity field is automatically populated once an entity is created using the name and TIN values. This field will be used to form the magnetic media reports and could be used to make custom reports in NetSuite.
- (i) Note: Enter the company's TIN on the field Tax Register Number, under the Tax Registers subtab. Multiple tax register numbers are non-admissible. If more than one tax register number for Colombia is submitted on the tab, only the first one on the list will be shown on the TIN field.

To set up Colombia-specific User Preferences:

- 2. On the **Set Preference** page, go to **General** subtab.
- 3. In the **Localization** section, set the following:



- a. In the **Language** field, select Español (Latinoamérica).
- b. In the **Search Sorting** field, select Language Specific if you want sorting to follow the alphabetical order of the language you selected.
- c. In the Language for the Help Center field, you can also select Español (Latinoamérica).
- d. If you are using OneWorld account and you defined and accounting context under Setup > Company > Preferences > General Preferences (Administrator), then the **Accounting** Context field appears. Select a local accounting context if you want to view the chart of accounts structure and names in the language that you selected.
- e. In the **Time Zone** field, select "(GMT-05:00) Bogotá, Lima, Quito" based on your location.
- f. In the **First day of the week** field, select Sunday.
- g. In the **Date Format** field, select DD/MM/YYYY.
- 4. Click Save.

Displaying Currency

Colombian pesos require the use of decimal fractions, they are usually displayed as COP 1,123.05.

The decimal precision of a currency is determined by the value selected for Format on the Currency record. For example, the United States (English) format has 2 decimal places and the Japan (Japanese) format has 0 decimal places. Decimal precision can not be edited in the user interface. If you need a different decimal precision, contact NetSuite Customer Support for assistance.

NetSuite provides value-added tax (VAT) and withholding tax tracking and reporting for businesses in Colombia.



The SuiteTax LATAM Engine SuiteApp enables you to meet the determined local taxes requisites. The companies that do business in different parts of the world must comply with different tax requisites from the government authorities. The tax engine SuiteTax LATAM Engine helps companies fulfill specific requisites and calculate taxes in their NetSuite transactions. SuiteTax LATAM Engine SuiteApp provides the deployment of a Tax Engine complement and a custom records structure so you can set up the tax definition in different contexts. The SuiteApp also provides a type of custom plug-in., the SuiteTax LATAM Engine Plug-in. You can use the custom complement type to create complement deployments in order to calculate a tax or a group of taxes. With SuiteTax LATAM Engine, you can set up tax calculations such as the income tax, the tax-added value (VAT), tax withholding and others. SuiteApp does not provide a predefined plug-in or record to calculate the taxes of any country or region. You should create your own complements and records or download another SuiteApp that can provide the records. For example, NetSuite offers the data records of the Colombia LATAM tax motor, which provides a group of plug-ins and records so that you can calculate the taxes in Colombia. Colombia Tax Codes

Tax codes determine how much tax is paid on each transaction line item. Make sure that the properties and rates of your tax codes are correct.



Important: In accounts that have SuiteTax enabled, SuiteTax Engine and SuiteTax Data Records SuiteApps provide the VAT tax type and tax codes for Colombia. For more information, see the help topic Automatic Tax Record Provisioning

Tax Determination Rules in the SuiteTax LATAM Engine

In general, taxes are not applied to all the transactions in the same way. Some taxes only apply to services and others only apply to goods. Local governments can restrict some taxes to specific company types or establish special tax regimes. To allow NetSuite to identify the taxes that should be applied to a transaction, the SuiteTax LATAM Engine provides the tax definition rules record. The records collect information related to the tax definition process, such as what affiliates and items are tax codes, rates and effectiveness periods subject to. Colombia Electronic Bank Payment Components

The Colombia Localization SuiteApp includes templates for generating bank payment files in the format specified by the main Colombian banks: Bancolombia, Banco de Bogotá and Davivienda. To enable these templates, the administrator must first install the Electronic Bank Payments SuiteApp, followed by the installation of the Colombia Localization SuiteApp. By doing so, the Colombia Localization SuiteApp adds the localized templates as payment electronic formats in the Electronic Bank Payments SuiteApp, and automatically installs them.

Colombia Context

The Colombia Localization SuiteApp provides Colombia-specific custom fields to comply with tax and other government requirements in Colombia.

In NetSuite OneWorld accounts, Colombia-specific custom fields are available when one of the following conditions is met (the first condition has the highest priority):

- The subsidiary country of the record is Colombia.
- If no subsidiary is selected, the subsidiary country of the NetSuite user is Colombia.

Most of the latest catalogs from DIAN are supported the SuiteApp. DIAN catalogs contain codes and values that describe or classify an entity, product or service, transaction, payment, tax category, industry type and other business elements. DIAN requires fields with these codes and values to be included in the Magnetic Media information files in Colombia and the electronic sales invoices for Colombia.

When you install the Colombia Localization SuiteApp, the catalogs are stored in NetSuite as custom records. Custom fields are automatically integrated or mapped to applicable NetSuite transactions or records to capture information in DIAN catalogs. The values you can choose from these custom fields are sourced from the catalogs.

Most of the DIAN custom fields are required by DIAN and you must specify values for them.

An advanced PDF template is delivered with the Colombia Localization SuiteApp. To customize the layout of the template, go to Customizations > Forms > Advanced PDF/HTML Templates and search for Colombia (transaction) PDF Template. For more information about the Advanced PDF/HTML Templates feature, see the help topic Advanced PDF/HTML Templates.



Important: When customizing a Colombia transaction form, select the Standard (transaction) PDF/HTML Template from the dropdown list. Do not select the Colombia (transaction) PDF Template on this record. The Colombia (transaction) PDF Template is used for Certification processes and therefore must be specified on the Electronic Invoicing Setup record only. For the Print Template, select Proveedor Tecnologico PDF Template.

You can send the generated e-documents (XML and PDF) to your customers. For more information, see the help topic Sending and Resending E-Documents.

Creating customers and vendors

Both customers and vendors will be created by default as NetSuite's companies (is person = F)

Leave the Auto field selected so that the name can be linked to the TIN or entity ID number.

When creating a customer (for interested customers, the values to fill in are optional) or vendors, partners, others, it is mandatory to fill in the following information and after selecting Colombia's subsidiary, the following fields will activate pursuant to the type of person:

- Nature: It should be defined if it is an individual or a legal entity, depending on that, the system will show the fields to be filled in as follows:
 - In the case of individuals, they will answer separate fields for First Name, Middle name, First last name and Second last name, as well as NetSuite's standard field Name of the company, on the primary information fields.
 - In the case of legal entities, they need to fill in NetSuite's standard field Name of the company, on the primary information field.
- Document type: The user should select the document type and the system will identify the DIAN code for each type of document.



- Taxpayer Identification Number: This field is filled in after clicking on Save for the register once the information on the Finances subtab > Tax Records is fulfilled.
- Verification digit: It is calculated by NetSuite after saving the entity, only when the document type corresponds to the DIAN codes 13 and 31.
- Invoicing notification email: Email address where the invoicing files will be sent to.
- **Tax regime:** It should be indicated if the entity is liable for VAT or not.
- **Tax scheme:** Select the tax identifier corresponding to the company.
- Tax responsibilities: Indicate the tax responsibilities assigned by DIAN in the RUT.
- Is it a consortium? Check the box to identify if the entity is a Consortium; if so, on the tab Relationships > Consortium assign the participant and the corresponding participation percentage.

On the Finances subtab/Tax Records subtab, the following fields should be selected:

- **Country**. Select the country that the Entity belongs to.
- State. According to the selected country, the corresponding fields will be displayed.
- **Link**. It is auto filled according to the selected country.
- Taxpayer Identification Number. The TIN or entity identification number

On the Address subtab:

 Assign the information about the entity's location and the Department and Municipality fields. DIAN requires numeric codes to identify its states and municipalities (cities); however, on User interface, the user should see the names of each one.

Employee Creation

On the Principal tab:

- Leave the Auto field selected so that the name can be linked to the TIN or entity tax number.
- Separate fields should be filled in for First name, Middle name, First last name and Second last name.
- Document type: The user should select the document type and the system will identify the DIAN code for each type of document.
- Identification number: Equivalent to the Tax ID natively generated by the system. This field is filled in after clicking on Save.
- Verification digit: It will be calculated by NetSuite only after saving the entity.

On the Address subtab:

 Department and Municipality register. DIAN requires numeric codes to identify its departments and municipalities; however, on User interface, the user should see the names of each one.

Create Items

To create an export item, take into account the fulfillment of the following fields:

- Brand
- Electronic invoicing code
- Tariff code

After assigning these fields on the items, the information will be reflected on the transaction line.



Currency Exchange Rate Update

On the Colombia Localization SuiteApp, the exchange rates automatic update is included from dollars to Colombian pesos in the NetSuite's Currency Exchange Rates standard register. It is a Programmed type of script and, currently, it is automatically executed at 1 am, according to the time zone set on NetSuite's general preferences.

If you want to modify the programming, go to Personalization > Script creation > CO Script Deployments | Update TRM, customdeploy_co_update_trm_sc_dp

Colombia Localization Field Mapping

DIAN requires fields with specific values to be included in the Magnetic Media Information Files and in the Electronic Invoices for Colombia.

The Colombia Localization Field Mapping feature enables you to map standard NetSuite fields to categories required by DIAN. The mapped values are included in the Magnetic Media Information files after they are saved in the system.

To map standard NetSuite fields to categories required by DIAN:

- 1. Go to Setup > Colombia Localization > Colombia Field Mapping
- 2. Map the fields by specifying a value in the column at the right
- 3. Click Save.



Setting up the CO Account Mapping Custom Record

To set up the CO Account Mapping Custom Record:

- 1. Go to Customization > Lists, Records and Fields > Lists
- 2. Check that the CO Account Class, CO Account Group, CO Account List, CO Subaccount and CO Auxiliary Account lists are created and filled with the custom values according to the account classification required for the account.
- 3. Make sure that your NetSuite role has the corresponding permissions to set up the specific customized registers for Colombia.

To do the account mapping:

- 1. On NetSuite, go to Customization > Lists, Records and Fields > Register types.
- 2. Locate the CO Account Mapping customized register
- 3. Click on More > See Registers
- 4. Click on Create CO Account Mapping:
 - On the field Account (Register), designate the account on which the mapping will be carried out
 - On the field **Class**, designate the account digit by digit, accordingly.
 - On the field **Group**, designate the account by pairs of digits, accordingly.
 - On the field **Account**, designate the account four by four digits, accordingly
 - On the field Subaccount, designate the account six by six digits, accordingly
 - On the field Auxiliary Account, designate the account eight by eight digits, accordingly.

To set up the CO Account Mapping Custom Record through CSV Imports

- 1. Create a saved search of the subsidiary accounts. You can export the results in a CSV file and add the required fields.
- 2. Go to Lists > Search > Saved searches > Create
- Click on Account.
- 4. On the Criteria subtab, set the subsidiary filter and select your subsidiary in Colombia.
- 5. On the **Result** subtab, set the results to only include the columns Internal ID, Number and Name.
- 6. Click on Preview.
- 7. On the results page, click on the icon **Export CSV.**
- 8. Save the CSV file with the search results in the account.
- 9. Add the following required fields on the **CO Account Mapping** register:
 - Class
 - Group
 - Account
 - Subaccount
 - Auxiliary account
 - Magnetic Media Dian Code (it is DIAN's concept which the Magnetic Media information account belongs to)
- 10. Save the CSV file with the account levels information and the concept it belongs to



- 11. Import the CSV file saved on NetSuite. Go to Setup > Import/Export > Import registers on VSV. Select the following options for the CSV file import:
 - Import type = Personalized registers

The Manage DIAN Measurement Units page enables you to enter in NetSuite the DIAN unit codes that are most relevant to your business.

Colombia Electronic Invoicing Overview

In Colombia, taxpayers are required to use electronic invoicing for all their business transactions. Electronic invoicing in Colombia is known as CUFE (Unique Electronic Invoicing Code) and it must follow a specific format prescribed by DIAN.

The Colombia Localization SuiteApp enabled you to generate and process outbound and inbound edocuments to comply with CUFE in Colombia.



The following table lists the transaction types currently delivered by outbound and inbound Colombia Electronic Invoicing:

The XML e-documents generated from the supported transactions require certification from DIAN as a prior step to being forwarded to customers.

In Colombia, technological service providers (certification providers authorized by DIAN) are responsible for all the communications between NetSuite and the Colombian tax authorities for certification purposes.

After the CUFE is approved and stamped by DIAN, the technological service providers returns the certified CUFE to NetSuite.

The Colombia Localization SuiteApp includes integration with three pre-configured Colombian technological service providers:

- Dispapeles
- Facture
- GoSocket

The SuiteApp also includes default e-document packages containing sending methods for certification and e-document templates in XML format to let you integrate with the technological service providers.

Colombia Electronic Invoicing Administrator Guide



Important: To use the Colombia Electronic Invoice feature, you must first install and configure the Electronic Invoicing SuiteApp, which provides the framework for generating electronic sales invoices and supports the e-document certification process. See the help topic Electronic Invoicing Administrator Guide.

The Colombia Localization SuiteApp includes default e-document packages, e-document templates, and e-document certification sending methods for using electronic invoicing in Colombia. For an overview of these components, see Colombia Electronic Invoicing Overview.

The administrator should first install the Electronic Invoicing SuiteApp, followed by the installation of the Colombia Localization SuiteApp. By doing so, the localized packages, certification sending methods, and templates are added to the Electronic Invoicing SuiteApp and they are automatically installed for the user. You can view the installation status of these components on the Colombia Localization Components page. For more information, see Viewing Colombia Localization Component Installation Status.

To create new packages, templates and sending methods, see the help topics Creating E-Document Packages, Creating E-Document Templates and Creating E-Document Sending Methods

The sending method for sending certified e-document files to the customer (XML and PDF) must be manually created. For more information, see the help topic Setting Up an Email Sending Method for E-Documents.

You can restrict the editing of transactions based on the e-document status selected on an outbound e-document template record. For more information, see the help topic Creating E-Document Templates.

After installing the Colombia Localization SuiteApp, the account administrator must configure the technological service provider's credentials and other relevant settings. This is a one-time setup task to enable a technological service provider and store its credentials in NetSuite. Each tech provides user credentials (for example, username and password) to be used when invoking their test or production web services.

Electronic Invoicing Field Mapping

For Electronic invoicing in Colombia to properly function, it is necessary to carry out field mapping against the values set up in the base; the values associated to measurement units, payment methods, tax codes, currencies and discount codes should be mapped.

To map electronic invoicing fields for Colombia:

1. Go to the menu Setup > Colombia Localization > Colombia Field Mapping



- 2. From the categories on the screen, you will be able to choose the data category you want to map
 - Payment method: DIAN codes mapping against payment methods registered on the base; choose the applicable code and click on Save.
 - **Measurement unit:** Measurement unit mapping according to their type against DIAN codes; for the mapping, choose the measurement unit category and the unit type that requires mapping. The units applicable to this measurement unit type will be displayed. Choose the applicable code and click on Save.
 - **Discount codes**: Discount item mapping per subsidiary against DIAN discount codes; after choosing the category, you will be able to choose the subsidiary the item belongs to in order to assign the corresponding discount code.

Tax codes:

- Tax code mapping against DIAN registered codes; after choosing the DIAN code category, the tax code will be mapped against the code reported to DIAN.
- If you choose the "Tax information" category, the information on withholding types will be included and it will indicate if the tax code applies as VAT or if it is a withholding or a selfwithholding.
- Currency: In the Currency category, the currencies that the translation categories for the written amount are applied to are configured, for instance, CO_PESO for pesos and US_DOLLAR for dollars.

Colombia Localization and API Secrets

In order to maintain the integrity and safety of the keys and passwords delivered by the technological service provider, it is necessary to set up API keys.

To set up API keys for Colombia:

- 1. Go to the menu Setup > Company > API Secrets
- 2. Click on "Create new"
- 3. Fill in the key information according to the technological service provider's indications:
 - GoSocket: It is necessary to build the key as the union between the user and password value separated by a colon (:), that is user: password; the resulting value should be translated to base64, you can use a web page (base64encode) or ask your organization's technical staff for advice. Fulfill the ID (custsecret) set up by the application in the value "user" from the configuration CO Electronic invoicing setup.
 - **Dispapeles**: Create a secret API value for the user and a secret API value for the password. Fulfill the ID (custsecret) set up by the application in the values "user" and "password" from the configuration CO Electronic invoicing setup.
 - Facture: Create a secret API value for the user and a secret APU value for the password. Fulfill the ID (custsecret) set up by the application in the values "user" and "password" from the configuration CO Electronic invoicing setup.

Electronic Invoicing Setup

For proper functioning of electronic invoicing in Colombia, it is necessary to have the Electronic Invoicing bundle (436209) installed, to have carried out the field mapping described in the mapping module, to have the registers associated to the resolutions as indicated in the manual associated to the resolutions and, additionally, to carry out the setup associated to electronic invoicing.



To set up electronic invoicing for Colombia:

- 1. Go to the menu Setup > Colombia Localization > Electronic invoicing setup
- 2. Click on **Create CO Electronic Invoicing Setup**, and fill in the setup according to what the technological service provider delivered, as well as the organization's preferences. This configuration must be carried out per subsidiary.
 - You must fill in the information related to the service connection, the PDF's predetermined languages and you will find the predetermined information for the PDF generation per supported transaction on the tabs.
- 3. After you finish, click on **Save**. The setup must be unique per subsidiary; if you attempt to generate two setups per subsidiary, the system will not allow it.

Electronic Invoicing Numbering Setup

To setup the different DIAN resolutions on each one of the documents, make sure that the role A/R Clerk is authorized for the customized CO Resolution/Authorization register.

To set up electronic invoicing numbering for Colombia:

- 1. Go to Setup > Colombia Localization > Electronic invoicing numbering
- 2. On the field **Name**, indicate the name of the resolution corresponding to the transaction.
- 3. On the field **Transaction category**, indicate if it is for Sale Transactions or Purchase Transactions.
- 4. The **subsidiary** corresponding to the numbering.
- 5. On the field **Prefix**, indicate the prefixes corresponding to the numbering.
- 6. On the field **Resolution number**, indicate DIAN's authorized resolution number
- 7. **Initial Number** and **Final Number**, assign the range authorized by DIAN.
- 8. Validity initial date and Validity final date, assign DIAN's authorized date
- 9. On the field **Current Number**, indicate the number that the transaction should start with.
- 10. On the field **Transaction type**, select the types of transaction that apply to this numbering.
- 11. On the field **Contingency**, mark the checkbox if the numbering corresponds to a contingency numbering.
- 12. On the field **Sales Point**, mention the sales point associated to the resolution
- 13. On the field **Technical Key**, indicate the technical key associated to the resolution

Manual Invoicing

There will appear two tabs on the transaction, the "Electronic Document" subtab, related to NetSuite's Electronic Invoicing module and the tab "Information on CUFE", where you will find the necessary information for electronic invoicing in Colombia.

Enter the information required on the tab "Information on CUFE", such as resolution, payment method (if applicable), invoice type or credit memo type, operation type and service date. On the tab "**Electronic Document**", enter the XML template that you want to use depending on the type of transaction, if it is foreign trade or not, and the available sending method for the certification; follow the "Electronic Invoicing" module indications described in the help center.

Click on "Generate electronic document", according to the electronic invoicing module instructions. In case it is not generated, check on the module's audit if any of the required fields is empty.



For instance, in the previous case, the fields associated to the resolution, payment method and operation type on the invoice were empty.

After the document is generated, click "Certify electronic document", according to the electronic invoicing module instructions. If an error generates throughout the certification process, check the audit log, where you will be able to see the technological service provider status and the DIAN status.

If the document was successfully certified, its status will change to "Certification in progress", where the automatic PDF process will provide the certified documents.

Massive Invoicing

Go to the menu Transactions > Sales > CO Massive E. Invoicing

Select the mandatory information for the transactions filter. If you want to filter with another type of criteria, select the applicable fields and click on Filter or mark the checkbox Send without selection.

By clicking on Filter, you will see the transactions included in the criteria selected. Mark the checkbox at the beginning of the list and click on Send process.

If you marked the checkbox "Send without selection," just click on "Send process" and it will redirect you to the massive process screen.

After finishing the register, your status will appear as Completed or "Completed without errors." In case of finishing the process with detail errors, you will be able to see the mistake associated to the transaction so you can correct it and stamp it manually.

Colombia Electronic Invoicing Special Cases

- **Orders:** In the case of Orders, you should select the following fields:
 - DIAN operation type: 11-Orders
 - Designate the field Principal on the transaction line
- Samples without commercial value (100% discount): You must select the field Sample on the transaction line where the commercial sample applies indicating if it is a gift or a Sample and the field Sample Code to indicate the type of price (Other value, Commercial price, Reference price).
- Consortium Invoicing: At Entity level, check on the box Consortium to indicate it is a consortium and include the entities that belong to it, as well as their participation percentage, on the tab Relationships.
 - **Important:** For this invoicing type, the vendor Facture has no regard for this case
- Group Items Invoicing: For group items invoicing, you can check the box "Print Items" in the transaction form, which will allow you to visualize the member items on the invoice, but not the main

In case of not checking this box, you will visualize the main item, but not the member items.

- **Exportation Invoicing:** For this invoicing type, the specific foreign templates should be assigned in the section "Electronic document." At the CUFE information level, you should select the option "02 Export Sales Invoice" on the invoice type field. For INCOTERM, at the item line level, the tariff code should be assigned. In the item, the field Brand and Tariff code should be assigned.
- Contingency Invoicing: For this invoicing type, at CUFE information level, you should select the option "03 Biller Contingency Invoice" or "04 DIAN Contingency Invoice" on the invoice type field, according to each case. Specify the document type related to the contingency.
- Debit Notes: When using the transaction type Sales Invoice to do the Debit notes on the field "Transaction type," you must indicate it is a Debit note to quarantee an accurate certification.



Select the template associated to the Debit notes on the **E-document** subtab

Electronic Bank Payments for Colombia



Important: To use Electronic Bank Payment File Layouts for Colombia, you must install the Electronic Bank Payments SuiteApp, which provides the framework for generating electronic bank payment files. For more information about setting up the Electronic Bank Payments SuiteApp, see the help topic Setting Up Electronic Bank Payments

The Colombia Localization SuiteApp provides some templates to help you generate electronic bank payment files to pay vendor invoices in Colombia.

The administrator should first install the Electronic Bank Payments SuiteApp, followed by the installation of the Colombia Localization SuiteApp. By doing so, the Colombia Localization SuiteApp adds the Electronic Bank Payment file templates to the Electronic Bank Payment SuiteApp. You can view the installation status of these templates on the Colombia Localization Components page. To visualize the Colombia Localization components installation status, go to Setup > Colombia Localization > Colombia Localization Components.

The templates provided with the Colombia Localization SuiteApp support payment file formats specified by the major Colombian banks. These are the templates currently delivered:

- Bancolombia
- Banco de Bogotá
- Davivienda

Before you can use a payment file format for Colombia, you must set up the relevant bank details and other information that the system requires. For more information about setting up bank records for your company, subsidiaries, and vendors, see Colombia Payment Formats

Setting Up Company Bank Records in Colombia

To set up company bank records:

Support Document for People not Liable for VAT

It is the document used to accredit the purchase of a good or service, and that the buyer must generate when doing transactions with a vendor who is not obligated to issue a sales invoice or an equivalent document.



Technical-administrative Prerequisites

For this module's proper functioning, the Colombia Localization package must be installed since this module uses libraries in the package. The initial configuration is also needed.

Prerequisites Setup

The module's initial set up must be carried out in the register Support Document for People not Liable for VAT

where you must complete the subsidiary the set up applies to, the language and the advanced template that will be used to render the PDF.

After this, the register Electronic Invoicing Numbering Setup setup must be carried out, where we will configure DIAN's authorization. This setup should be done on the Vendor Bill.

Lastly, the resolution title and paragraph must be set up pursuant to what each customers finds convenient. This is carried out in the Customization/Translations menu, then on the tab string and the CO Support Document collection must be filtered. After this, select the authorization and title label to set them up according to each customer's desires.

Development Feature Description

To generate a support document, a vendor invoice type of transaction must be created. Then select the previously set up resolution on the tab CUFE Information and mark the option Support Document. With this, a resolution number will be assigned to the document. Then once the document is saved, the option that will allow for the generation on the support document will appear, as can be seen in the following image:

After clicking on **Generate Support Document** the support document will be created on PDF format with the Vendor Bill information on a new tab. The PDF with the standard template looks like this:

Magnetic Media Information for Colombia

The Magnetic Media information or magnetic media is the group of data about operations with customers, vendors or third parties that individuals and legal entities must present periodically to the tax administration

The Magnetic Media tax information feature's objective is to validate the delivered data in order to execute greater control over taxes and therefore guarantee the compliance of taxpayers' substantial and formal obligations.

Magnetic Media information is presented through reports or formats. The law contemplates that these reports should be delivered in an XML format, through a tax pre-validator, which can be downloaded for free on DIAN's portal, which is why it is very important that all digits are meticulously checked on the files generated by NetSuite and do the corresponding tax adjustments.

The Colombia Localization SuiteApp supports the following formats established by DIAN, which can be generated from the information created on NetSuite's transactions:

Format	Format name
1001	Account and withholding payments and deposits
1003	Withholding at the source practiced
1005	Deductible VAT tax
1006	Generated VAT tax



1007	Received income
1008	Accounts receivable balance
1009	Accounts payable balance

Each format is formed by a series of concepts that classify each Accounts plan account. See account setup on Setting up the CO Account Mapping Custom Record.

Technical-administrative requisites

For proper functioning of the Magnetic Media information module, go to (Setup > Colombia Localization > Magnetic Media information setup), the minimal setup is included on the SuiteApp.

It is necessary to set up each one of the formats for the cases where accounts or tax codes apply, as mentioned below

- Format 1001: In the case of the format 1001, the applicable configurations are the ones related to minor concepts and quantities. In terms of the columns, the first one is obtained from the balances related to the setup concepts; the rest of the columns depend on the applicable tax codes to each one of them, this is why the columns must be set up with their respective codes. If a column is not included, it would appear empty.
- Format 1003: In the case of the format 1003, the applicable configurations are the ones related to concepts. In terms of tax code, a customized field "Withholding category" is included. The strong withholding category codes are the ones included in the report.
- Format 1005: In the case of the format 1005, based on VAT information, the checkbox "Tax code" is included on the tax code, which indicates that it is VAT tax code to include the deductible movements generated in the following transactions: credit memo, cash refund, journal, invoice and cash sales.
- Format 1006: In the case of format 1006, based on VAT information, the checkbox "Tax code" is included on the tax code, which indicated that it is a VAT tax code to include the generated movements registered in the transactions vendor note, vendor bill and journals
- Format 1007: In the case of format 1007, at a regulatory level, the applicable setups are the ones related to minor concepts and quantities. In terms of reports setup, it is necessary to include the income accounts that correspond to each one of the report columns (refer to the Magnetic Media information setup section).
- Format 1008: In the case of the format 1008, at a regulatory level, the applicable setups are related to concepts.
- Format 1009: In the case of the format 1009, at a regulatory level, the applicable setups are related to concepts.



Important: it should be assured that the entity's information be found correct, complete and without any missing information (refer to the entity's configuration at Colombia Localization Features, that the transactions have third parties assigned, and that the accounts be found mapped with their respective Magnetic Media information concept. See Setting up the CO **Account Mapping Custom Record**

Magnetic Media Information Setup

For proper functioning of the Magnetic Media information formats generation, you should make sure to have the account mapping, that the entities have the localization fields assigned and that the following configuration is established:

 Account Mapping: On the customized register Setting up the CO Account Mapping Custom Record, you must carry out the account mapping with the corresponding concepts.



- Magnetic Media Reports Setup: Go to Setup > Colombia Localization > Magnetic Media information setup > Create
 - According to the format characteristics, the fields required to identify each column's specifications in the format will be enabled.
- Report Execution: To execute the Magnetic Media information reports, go to the menu Reports -> Colombia Reports -> Magnetic Media Information Generation, where you will select the subsidiary, the reports to be generated, the type of delivery and the period.

Note: If the base does not have a multibook, the accounting book option will not appear.

By clicking on "Generate report", you will be redirected to the execution audit register, where you will be able to see the process and the selected data on the generation screen.

Upon completion, the generated XML and Excel files with the information obtained from the system will appear.

Withholding Certificates: A withholding certificate is one of the formal obligations of income, sales, industry and trade tax withholders. It is a document that the withholding agent issues to the vendors, creditors and others related certifying the value paid for the acquisition of goods or services and the practiced withholdings in a determined period.

To generate the withholding certificate, go to Reports > Colombia Reports > Withholding Certificates > New. Select:

- Certificate type
- Subsidiary
- Issuance date
- Vendor
- Notes
- Date range

Click **Submit** and wait for the process to finish (see **Status**). then click on the **Subtab Detail** to see the PDF.

Colombia Localization SuiteApp Limitations and Best Practices

Before using the Colombia Localization SuiteApp, be aware of the current limitations and best practice recommendations.

Best Practices When Installing the Colombia Localization SuiteApp

When installing the Colombia Localization SuiteApp, be guided by the following recommendations:

- Enable the SuiteCloud features listed in the prerequisites section before installing the required SuiteApps for Colombia.
- Install the required SuiteApps for Colombia before installing the Colombia Localization SuiteApp.
- The permission with the highest CO Invoice Resolution level should be designated to a specific role for the invoice numbering setup.
- Make sure the Third-Party Entity field is enabled for all the transaction forms both at a line and header level.
- If you use group items in sales transactions, you should check the field Manual Third-Party Mapping so that the script fills in the field Third-Party Entity at a line level, otherwise this field will not be filled in and this affects third-party and Magnetic Media reports



- When doing the invoice numbering setup, the field Current Number should designate the number that the invoice should start with.
- For the massive invoice process, the role must have the permission with the highest CO Massive invoicing process level.
- To identify documents with error or things pending from the certification process, add the SuiteApp. "Electronic documents" to your control panel.
- Take into account that the delivery of electronic documents to the customers is directly carried out by a technological service provider.
- The duration of the XML assignment in the certified transaction is approximately 15 minutes.
- For the Credit Memos certification, it should be guaranteed that the invoices or documents related should be previously electronically certified before DIAN.
- Make sure that the following fields in the Vendor Bill form on the CUFE subtab are visible for filling to obtain the Support Document:
 - Resolution Number
 - Support document
 - Transaction type
 - Resolution

Other Known Limitations

If the entity requires the use of multibook accounting, the primary book must be expressed in Colombian pesos (COP) to achieve the reports of the Location of Colombia and ensure that third parties are in all transactions. In case a specific ledger entry is required and an account of account receivable type or account payable type is assigned, the entity field is not available, therefore the transaction would run out of related third party.

The new DIAN Resolution considers a new type of electronic document being released on May 2022, which is not supported on this version of the SuiteApp.

- Impuesto al valor agregado (IVA)
- Retención en la fuente (RETEFUENTE)
- Retención de industria y comercio (RETEICA)
- Retención en la fuente por IVA (RETEIVA)

The SuiteTax Latam Engine - Colombia Records SuiteApp also provides a set of predefined tax determination rules for specific taxation scenarios.

The tax determination rules are available as CSV files that you can import to your account according to your business needs. Use the predefined files as examples or basic structures for you to set up your own tax determination rules.

The script directly creates the following record types:

- Nexus
- Tax code
- Tax type



Tip: If you notice that the predefined nexus, tax code, or tax type records are missing from your account, view the script's execution log. On the execution log, you can verify if errors occurred. For more information, see the help topic Using the Script Execution Log Tab.

The script also triggers the CSV import that creates the predefined records for the following record types:

- Item code
- Line of business
- Tax regime



The predefined nexus provided is for the country of Colombia. The predefined tax type and tax code records include the taxes mentioned in the SuiteTax Latam Engine - Colombia Records Overview. The predefined item code, line of business, and tax regime records include the main economical activities and items from Colombia.

Before you start using the SuiteTax Latam Engine - Colombia Records SuiteApp, you must verify the status of the import. The SuiteApp is ready to use after NetSuite completes the import.

To verify the import status of the predefined records:

- 1. Go to Setup > Import/Export > View CSV Import Status.
- 2. In the Job Status list, verify the status information for the following jobs:
 - CUSTOMRECORD FTE ITEMCODE
 - CUSTOMRECORD FTE LOB

When you install the SuiteTax Latam Engine - Colombia Records SuiteApp, NetSuite automatically creates the following tax type records:

- IVA CO
- RETEFUENTE CO
- RETEICA CO
- RETEIVA CO

However, the predefined tax type records do not include any account information to indicate where NetSuite should post the tax amounts in the balance sheet.

Before you start using the SuiteApp to determine and calculate taxes in your transactions in Colombia, add the account information to the tax type records.

Adding Tax Accounts to the Predefined Tax Types for Colombia

The accounts you select in the tax type records indicate where in the balance sheet NetSuite posts the tax amounts.

To add tax accounts to the predefined tax types for Colombia:

- 1. Go to Setup > Tax > Tax Types.
- 2. Click **Edit** next to the tax type record you want.
- 3. In the Nexus column, select Colombia.
- 4. In the Payables Account column, select an account to which taxes on sales transactions for the nexus should be posted.
- 5. In the Receivables Account column, select an account to which taxes on purchase transactions for the nexus should be posted.



- 6. Click Add.
- Click Save.

The SuiteApp provides predefined tax determination rules for the following taxes:

- Impuesto al valor agregado (IVA)
- Retención en la fuente (RETEFUENTE)

For each tax, the SuiteApp provides different predefined rules that can apply to the following tax regimes:

Depending on the tax, the rules apply to either goods (bienes declarantes) or services (servicios declarantes).

The predefined tax determination rules include generic information for tax calculation in Colombia. After you import the CSV files and create the tax determination rules records in your account, you must set them up with your company-specific information.

Each type of tax has two files that you can use to create different record types:

- A CSV file to create tax determination rules records
- A CSV file to create tax determination settings records related to the rules

You should download the files that are most relevant to your needs.

 - d. In the CSV Column Delimiter field, select Semicolon.
 - e. In the CSV File(s) field, choose if you are uploading one or multiple files.

 - click Next.

Tax Determination Rules Preferences for Colombia

The predefined tax determination rules provided by the SuiteTax Latam Engine - Colombia Records SuiteApp include generic information for tax calculation in Colombia.



To use the predefined records to calculate taxes in your transactions in Colombia, you can include your company-specific information to the records.

For instance, you can select one or multiple subsidiaries to apply the rules only to transactions involving the selected companies. Alternatively, you can apply the rules to companies operating in a specific line of business.

You must also keep your tax determination rules preferences up to date to comply with regulatory or business changes. The SuiteTax Latam Engine - Colombia Records SuiteApp does not provide updates or maintenance for the predefined tax determination rules.

For more information about tax determination rules records, see the help topic Creating Tax Determination Rules in the SuiteTax Latam Engine.

After you set up your tax determination rules, ensure the following records are associated with the parameters to which the rules apply:

- Subsidiary
- Vendor
- Customer
- Item

For instance, ensure if the subsidiary and its customers are associated with the proper tax regime and line of business. Also, if the item is associated with the proper item code. For more information, see the following help topics:
