7. **Remove and replace any damaged plywood @ \$95.00 per sheet additional Initial**
 - A. Sun Coast Roofing to credit (10) sheets free of charge
8. Remove and replace any damaged dimensional lumber at \$9.00 per foot
9. Re-nail entire roof deck with 8-D ring shank nails to meet The new 2021 Florida building and wind uplift code.
10. Inspect Wall Flashing
 - A. Remove and replace if required at \$6.00 per linear foot.
11. Install manufacturer approved synthetic deck covering over the entire roof deck.
12. Install Peel and Stick underlayment to the entire roof deck on top of the synthetic underlayment.
