20-456 **Resolution to recognize first responders "our heroes" by City Council and the Mayor.** Moved by Councilperson Pietila and second by Councilperson Carter.

WHEREAS, it is the sense of this body to pay proper tribute to individuals of great character and whose lives exemplify the highest ideals of humanity; and,

WHEREAS, on September 28, 2020, Oakland County Deputies and Waterford Regional Fire Station 6, were dispatched to the 100 block of Parkdale Avenue in the City of Pontiac for a 10-month-old infant who was unconscious and not breathing; and,

WHEREAS, Lieutenant James Todd, and Waterford Regional Firefighter Paramedics Kenneth Estell and CJ Waldron arrived at the scene and within a split-second, determined that time was of the essence and there was no time to wait for EMS, so they loaded the child into the backseat of a patrol car and continued performing CPR while Deputy John Dean drove the patrol car to McLaren Oakland Hospital; and,

WHEREAS, Deputies Samuel James, Colin Cavanaugh, Brandon Nolin, Ahmed Alzayadi and Brian Blackburn also took immediate action by assisting with traffic and clearing a path for the patrol car to arrive at the hospital expediently and safely; and,

WHEREAS, as a consequence of the life-saving measures, quick thinking, proficiency, training and collaboration between Oakland County Deputies and the Waterford Regional Firefighters, the infant was resuscitated; and,

WHEREAS, theses First Responders are truly heroes in every sense of the word as they are motivated by selflessness, moral and physical courage as they risked their own lives to save the life of another in the midst of a global crisis, the COVID-19 pandemic.

NOW, THEREFORE BE IT RESOLVED, that the Mayor of the City of Pontiac and the members of the Pontiac City Council on behalf of the citizens of Pontiac, recognize and salute our First Responders for their contributions of leadership, self-sacrifice, and heroism to the community.

20-460 Resolution to reduce the spread of COVID -19 by requesting that RFP's for both the replacement of the chairs in the Council Chambers along with cleaning the ventilation ducts in Council Chambers, be issued immediately. Additionally, this resolution request that the purchase orders for both the chairs in Council Chambers and the cleaning of the ventilation ducts be included and submitted to Oakland County in the CARES cost reimbursement for Pontiac and the replacement of the chairs and the cleaning of the ducts be completed before December 31, 2020. WHEREAS, on April 14, 2020, the Pontiac City Council in an attempt to reduce the spread of the COVID-19, passed a resolution authorizing the Mayor to contract with Restoration 1 in an amount not to exceed \$15,000.00 for the cleaning, sanitizing and disinfecting of City Hall, 50th District Court, Ruth Peterson Senior Center and Bowens Senior Center.

WHEREAS, to date, the deep cleaning, sanitizing and disinfecting of City Hall, 50th District Court, Ruth Peterson Senior Center and Bowens Senior Centers have not been cleaned; and

WHEREAS, during budget discussions and amidst the peak of the COVID-19 pandemic, the City Council and the Executive discussed and agreed to remove the fabric seats in Council Chambers and replace them with vinyl seats; thereby, allowing for proper routine cleaning and disinfecting; and

WHEREAS, to date, the seats have not been removed or replaced; and

WHEREAS, during budget discussions, there was further discussion regarding issuing RFP's for ventilation cleaning of the Council Chambers; and,

WHEREAS, due to COVID-19, the Michigan Legislature passed legislation allowing for public bodies to meet virtually until December 31, 2020; and,

WHEREAS, COVID-19 more specifically CDC social distancing guidelines, mandate that Council Chambers be limited to 14 people; and,

WHEREAS, due to the increased costs incurred by the City due to COVID-19, the City of Pontiac upon signing the Interlocal Agreement with Oakland County, is entitled to CARES reimbursable expenses of up

to One Million, Five Hundred and Thirty-Three Thousand, One Hundred and Eighty-Seven (\$1,533,187.50) Dollars and Fifty Cent; and,

WHEREAS, both the replacement of the vinyl chairs and the cleaning of the ventilation ducts in Council Chambers are reimbursable expenses as verified by the Office of the Oakland County Executive; and,

WHEREAS, the City of Pontiac can make several submissions to Oakland County for reimbursement until the deadline of November 30, 2020.

NOW THEREFORE BE IT RESOLVED, the Pontiac City Council is requesting that RFP's for both the replacement of the chairs in the Council Chambers along with cleaning the ventilation ducts in Council Chambers, be issued immediately.

BE IT FURTHER RESOLVED that the purchase orders for both the chairs in Council Chambers and the cleaning of the ventilation ducts be included and submitted to Oakland County in the CARES cost reimbursement for Pontiac and the replacement of the chairs and the cleaning of the ducts be completed before December 31, 2020.

WHEREAS, the City of Pontiac and Oakland County have entered into an agreement pursuant to the Urban Cooperation Act of 1967, 1967 Public Act 7, MCL 124.501 *et seq.*, for the purpose of County distributing a portion of its CARES Act funds to the City. County has allocated a portion of its CARES Act funds to be distributed to CVTs within Oakland County, which will be used to assist CVTs in meeting certain areas of need caused by the COVID-19 pandemic.

NOW THEREFORE BE IT RESOLVED, the City Council of the City of Pontiac approves the agreement for Cares Act Distribution between Oakland County and City of Pontiac and authorizes the Mayor to sign the agreement on behalf of the city.

WHEREAS, the City of Pontiac timely approved the FY 2020-2021 budget on June 29, 2020; and WHEREAS, the adopted FY 2020-2021 General Fund budget includes appropriations in the Finance Department for salaries for personnel using account number 101-206-702.000; and an appropriation for other professional services using account number 101-206-818.000.

WHEREAS, the appropriation for account number 101-206-702.000 is \$311,250 and the appropriation for account number 101-206-818.000 is \$140,000; and

WHEREAS, section 5.106 of the Charter states "after adoption of the appropriations ordinance, and upon at least one week's notice in a newspaper of general circulation in the City, the Council by a resolution of five members, may amend such ordinance to authorize the transfer of an unused balance appropriated for one purpose to another purpose, or to appropriate available revenues not previously appropriated."; and WHEREAS, the proposed appropriation increase is \$81,000 for account number 101-206-702.000 to \$392,250; and the proposed appropriation decrease is \$81,000 for account number 101-206-818.000 ti \$59,000; and

WHEREAS, the proposed appropriation transfer will be used to increase the Finance Director Salary from \$50,000 to \$131,000.

NOW THEREFORE, BE IT RESOLVED that the City Council authorizes the City Clerk to publish the notice of the budget amendment in the Oakland Press.

WHEREAS, the Emergency Manager seeking to cut costs, sought to demolish the Phoenix Center which triggered a lawsuit with Ottawa Towers; and,

WHEREAS, the city's Legal Department, after several unsuccessful appeals, advised the Pontiac City Council to enter into a settlement agreement with Ottawa Towers; and,

October 20, 2020 Approved Minutes

WHEREAS, the City of Pontiac entered into a settlement agreement with Ottawa Tower II, LLC and the North Bay Drywall, Inc. Profit Sharing Plan & Trust on November 1, 2018; and,

WHEREAS, the parties participated in mediation and agreed upon the material terms of the settlement of their disputes; and,

WHEREAS, in consideration of the immediate discharge of all liens and encumbrances on the Phoenix Center, the City was required to pay Three Million Five Hundred Thousand (\$3,500,000.00) Dollars upon execution of all settlement documents in addition to Three Hundred and Fifty Thousand (\$350,000.00) Dollars in full and final reimbursement for all attorney fees and costs; and,

WHEREAS, the section entitled Maintenance, Repair and Improvements to the Phoenix Center and Tunnel, more specifically, section 6.2 of the settlement agreement, requires that in addition to the payments set forth in the Agreement, the City shall pay up to Six Million (\$6,000,000.00) Dollars over a ten (10) year period beginning as of the Effective Date of the Agreement for the maintenance and capital repair of and improvements to the Phoenix Center necessary to bring and maintain the Phoenix Center into conformance with the requirements of the International Property Maintenance Code (2015 edition), as referenced in the Michigan Building Code and the Michigan Rehabilitation Code (2015 edition).

WHEREAS, on April 28, 2020, the Pontiac City Council in an effort to comply with the Settlement Agreement as well as being good stewards and overseers of the funds of the City; passed a resolution for a budget amendment requiring that Seven Million (\$7,000,000,00.) Dollars be taken from the general fund (101) and allocated to the Phoenix Center (585-564-974.035) for parking structure repairs. Subsequently, the Council further provided that these funds be secured in the 2020-2021 fiscal year's budget.

WHEREAS, to date, there have been no repairs made to the Phoenix Center and the Executive has indicated to the Council that the City will be going back to mediation.

NOW THEREFORE BE IT RESOLVED, that the Pontiac City Council on behalf of the Citizens of Pontiac, request that the mediation date, time and location be provided to the Pontiac City Council during the Council meeting on Tuesday, October 13, 2020.

BE IT FURTHER RESOLVED, the Council further requests, that the date, time and location of any and all legal proceedings relating to the Phoenix Center be provided to the Council in writing, at least two weeks (14 days) prior to the actual date of the proceeding.
