

This agreement is between: (Sellers) Ken and Angie Miller, owners and breeders of Weaver Dairy Goldens (WDG), and the below listed Buyer(s) regarding a Male / Female puppy from the litter of _____. Whelped ____/____/_____ Color/Markings _____

BUYER SHOULD INITIAL TO THE LEFT OF EACH PARAGRAPH:

____ I, the buyer, enter into this agreement with full knowledge that I assume all responsibility for the life, health, and well being of this puppy. I understand that raising a Golden Retriever is a big responsibility that may last for as long as 20 years. Should this puppy EVER develop ANY health issues (e.g., diarrhea, dysplasia, cancer, allergies, temperament problems, etc.), I will notify the breeder immediately, or as soon as possible. WDG is not responsible for illnesses contracted after the puppy leaves (e.g., parvovirus from visiting public places, kennel cough contracted at the vet, etc.). If this puppy should expire, I agree to have my vet contact WDG, so they can discuss whether necropsy is necessary to determine cause of death. WDG is not responsible for lifestyle choices made by the buyer.

____ I, the buyer, have three (3) business days to take this puppy to a veterinarian visit for confirmation of health and may return it to WDG for a replacement puppy from a current or future litter (when available) if a serious birth defect or life-threatening illness is found. WDG is not responsible for the vet bill. Any neglectful conduct such as abuse, broken bones, or injury to the puppy beyond the sale will void this contract. If I choose not to take this puppy to a vet within three (3) days of purchase, this contract will be void unless other arrangements were made prior to pick up.

____ I understand that the puppy has been weaned onto a raw food diet and that illness (diarrhea, vomiting, etc.) caused by switching food will not entitle me to a refund or exchange of puppy. I understand that puppies have a sensitive gastrointestinal (GI) tract that can be disrupted by stress (physical, emotional, or chemical) and I will slowly wean the pup from the raw food provided by the breeder to reduce the chance of GI upset.

____ I understand that this puppy may be returned for any reason, at any time, and that it must be accompanied by AKC papers, microchip papers, puppy folder, vet medical records, and any other materials received with the pup. Seller is not responsible for vet bills.

____ I agree that any photos or emails that I send to WDG or that are posted on social media may be used on the WDG website or social media. Deposits to hold puppies (i.e., holding fees) are non-refundable. All puppies must be paid in full at pickup. WDG reserves the right to refuse a pup to any buyer at any time. If a holding fee has been placed, it may be returned, depending upon the circumstances surrounding the cancel of sale.

____ This contract does not insure any puppy against hip, elbow, eye, heart, or other diseases. We are very careful in breeding, to match the best traits (health, beauty and temperament) to produce the finest quality puppies. **The health of this puppy is guaranteed for two (2) years against genetic diseases if the following conditions are met:** Proper care by the buyer is essential to the future health of the puppy, including not over-immunizing. The health guarantee will be void if more than one vaccine, containing no more than 5 antigens (e.g., parvovirus, distemper, adenovirus 1 & 2, and parainfluenza or 5-way), is given during a single visit; if vaccines are given more often than every 4 weeks; if flea and tick protection is used improperly such as giving 3-month oral doses. A quality species appropriate diet should be provided (with raw 80/10/10, freeze dried, dehydrated, or cooked fresh food if possible), and avoidance of toxins (e.g., weed killer, lawn fertilizer, pesticides, chemical dyes in pet toys, etc). Spending more on a quality diet saves in medical bills over time. WDG can offer natural treatments for flea and tick, and heartworm protection as an alternative to pharmaceuticals.

____ WDG does not guarantee color, size, weight, coat quality, temperament, and ability to show, housebreak or reproduce. **All puppies are sold with limited AKC registration** unless other arrangements have been discussed and agreed upon by the breeder **prior to purchase**.

____ WDG has ultimate say in all decisions regarding the care and treatment of this puppy until the puppy leaves our care. WDG offers support for the lifetime of our puppies. The WDG Facebook group and website contain many educational materials and tips for reference. We welcome the buyer to stay in contact, including photos and attending the annual reunion party, as the puppy grows.

____ WDG may be able to keep a puppy beyond the 8 weeks go home date for an additional fee to cover the cost of food, if prior arrangements have been made. [Contract edited 2/26/2025]
