# Section 4: Bookings and Payment Conditions

# 4.1 Deposit for individual bookings

To receive confirmation of an individual booking (1-2 pax) requires a deposit of US \$500.00 per person.

# 4.2 Payment of remaining balance applicable for bookings

Beyond the booking deposit (see clause 4.1), 50% of the remaining balance is due no later than April 25th, 2025. The remaining balance is due January 15, 2026. We reserve the right to consider the contract cancelled if the payment conditions are not upheld, My Dive Trips, LLC will then enforce our cancellation policy as set in clause 5.

### 4.3 Payment Details

Payments for deposit and down payments must be made by cash, check, Venmo, PayPal, or Facebook Pay to My Dive Trips as. (the debitor bears ALL transaction fees).

## Section 5: Changes or Cancellations

#### 5.1 General

The date that My Dive Trips, LLC receives the announcement of change or cancellation to the booking will be the date used to determine which fees apply. On Saturdays, Sundays and public holidays the next working day will count.

## 5.2 Cancellation policy for bookings:

Up to 121 days prior to first day of stay as noted on the invoice a US \$500.00 cancellation fee per person applies.

120 to 90 days prior to first day of stay as noted on the invoice a US \$1000.00 cancellation fee per person applies.
