## **RSCA 2021 Key Accomplishments**

- Reactivated the RSCA Board of Directors, per Special Meeting Dec. 8, 2020, for reorganization, in which we revised the Bylaws to separate the RSCA from Lancaster city's control.
- Assumed responsibility for RSCA's finances, including transferring Fulton Bank account, our Fulton loan, and storage of the 48 animals from oversight of Rob Ecklin, former RSCA Director and Acting President.
- Obtained Officers and Directors Liability insurance, and Property Insurance for the full Carousel.
- Moved the 3 trailers with the carousel machine & components off city property to a new secure location.
- Operations Committee members opened and inspected the contents of the trailers.
- Met with Todd Goings of Carousels and Carvings, Marion, Ohio, to review renovation options.
- Held two volunteer work days to dust, clean and inspect the 47 animals in our main storage facility.
- Reviewed all financial, tax return documents, and early 2000's reports that could be located.
- Began to prioritize goals and objectives and priorities for the following:
  - organizational finances
  - evaluating carousel preservation needs and possible storage improvements
  - new community outreach, including rebranding and creating a media presence
  - opportunities to exhibit the Stoner Carousel animals and band organ
  - o seeking a partnering organization and potential site for the carousel.
