Volunteer's Waiver, Release, and Indemnity Agreement - Web Version

The undersigned, in consideration of participating as a volunteer at the Grace Christian Assembly Church ("Church") summer camp, hereby agrees to the following Waiver of Claims and Liability Release ("Agreement").

The Agreement is an important legal document. It is critical that you read and understand it completely. After you have done so, please print your name legibly and sign in the space provided at the bottom.

I give permission to Church and its agents to obtain, at Church's cost, information relating to my criminal history record from any jurisdiction. I understand that this information will be used in connection with any determination of my eligibility to work with or supervise campers who are minors.

I agree to observe and abide by all Camp policies and procedures and to follow any instructions given by Church regarding the Camp.

I understand and acknowledge that my responsibilities at the Camp may include observing and supervising the activities and behavior of campers and that I am obligated to report to Church any indications of improper behavior or circumstances by campers or others involving Camp operations and activities.

I understand and acknowledge that as a volunteer working at a camp with minors, I am considered a mandatory reporter in Missouri and that I am legally obligated to immediately report suspected or witnessed child abuse or neglect to state authorities. I agree to contact **MISSOURI CHILD ABUSE AND NEGLECT HOTLINE: 1-800-392-3738** if I suspect or witness child abuse or neglect.

I understand and acknowledge that the Church reserves the right to terminate the participation of any volunteer whose conduct may be considered, in Church's sole discretion, to be detrimental to or incompatible with the interests and security of the Camp.

I grant and authorize Church and its agents the right to take, edit, copy, publish, distribute and make use of my likeness solely in conjunction with the advertisement, promotion and digital communication of the Camp. I waive any right to compensation therefore or any right that I otherwise might have to limit or control such making or use.

To the best of my knowledge, I am in good physical condition and have no disease, physical limitation, health concern or injury that would be aggravated or would be the cause of any injury sustained, before, during or as a result of my participating in activities related either directly and/or indirectly at the Camp. In any event, I acknowledge and agree that I assume the risks associated with any and all activities in which I participate in at the Camp. I further give permission to be transported to the nearest hospital for treatment in case of an accident or

emergency, and I agree to pay all medical costs and expenses related to the medical care I might receive.

As a condition of being allowed to volunteer my services and time at the Camp for Church, I hereby voluntarily and absolutely release and discharge Church and any of its officers, directors, volunteers, agents, and representatives from and against any and all claims, damages, or liabilities, including reasonable attorneys' fees and court costs, or actions or causes of action for personal injury, property damage, or wrongful death that I may suffer arising out of or relating to my volunteering at the Camp, or by my participation in Camp activities and programs, or by the use of Camp facilities or equipment; whether or not such injuries or damages are caused by the negligence (active or passive) of Church and its agents or myself.

I agree to indemnify, defend, and hold harmless Church and its officers, directors, volunteers, agents, and representatives from any and all claims or causes of action by myself or by any other person or entity, and under no circumstances will I present any claims against said organization and said persons for personal injury, property damage, wrongful death caused by any act of negligence by Church. This indemnification provision shall survive the termination and/or expiration of the Agreement.

I agree that in the event of an injury to myself as result of my volunteering at the Camp, whether or not caused by the negligence (active or passive) of Church, or any of its agents or volunteers, I will be financially responsible for any and all of my own medical expenses or related costs in connection with the Camp. I assume and accept all risk of bodily injury, death, property damage and other harm connected with my participation in the Camp.

The Agreement shall be governed by and construed in accordance with the laws of Missouri.
