

**MINUTES OF THE REGULAR MEETING OF GOVERNING BOARD OF THE

THURSDAY, FEBRUARY 15, 2024**

The Governing Board of the Northern Arizona Fire District met this 21st day of February 15, 2024, at 6:00 p.m. for its regular monthly meeting at the Fire Administration Building at 2600 E Northern Avenue, Kingman, Arizona.

1. **CALL TO ORDER** – The meeting was called to order by Chairman Bailey at 6:00 p.m.
2. **PLEDGE OF ALLEGIANCE** – Chairman Bailey led the Pledge of Allegiance.
3. **ROLL CALL OF BOARD MEMBERS** – Board members present were Chairman Jim Bailey, Director Sue Brown, Director Mike Collins, and Director Tim Bonnee. Director John Bryant attended via Zoom.

5. **APPROVAL OF MINUTES** –

  - Director Bryant motioned to approve the consent agenda meeting minutes.

Collins agreed that he wanted to outline specifics on spending limits, as well as exactly what the cost to the district would be.
      - Director Collins motioned to approve the IGA as is but with the stipulation that an amendment be made for the chief spending limit be put in and verification of the cost to the district.
      - Chairman Bailey seconded. All in favor, motion carried.


- Admin Assistant explained that there was an email sent from the county treasurer outlining that, for this fund to start receiving interest, approval first needed to be given.
