A. Approval of the December Financial Report. Chairman Bailey made the motion to approve the December financial report as submitted. Director Wilkin seconded the motion. There were no questions or comments. Passed by unanimous decision.

B. Possible Executive Session for legal advice. Director Bryant made motion to move forward with Golden Valley Fire District to see if they are interested in a possible management agreement and to continue looking over resumes from other candidates that are received for the interim fire chief position. Seconded by Director Wilkin. No additional discussion. Passed unanimously.
- **D. Possible Executive Session for legal advice.** The Board may vote to go into executive session pursuant to ARS Sec. 38-431.03(A)(3) for discussion or consultation for legal advice with the attorney for NAFD regarding concerns raised by employee correspondence. Chairman Bailey made motion to go into executive session for legal advice pursuant to ARS Sec. 38-431.03(A)(3) for consultation with the attorney for NAFD concerns raised by employee correspondence. Seconded by Director Wilkin. Director Bryant stated to the audience that when the Board goes into executive session, they are allowed to only discuss one item at a time. Motion passed unanimously. Executive Session started at 7:27 pm.

The Board discussed topic points of the letters, Chairman Bailey stated the Board is for administrative oversight and does not cover operations. He encouraged the personnel to attend the meetings to voice any concerns they may have. Topics discussed were personnel being encouraged to attend meetings, loss of personnel, retention, engine replacement, the board receiving notice of IGA agreement with Kingman expiring and the current status of the Interim Fire Chief position.
