- Chief Cunningham states that the administration office does not have any fire safe file cabinets. He stated that this was placed in the budget and is now presenting it to the board for approval.
 - Director Bell motions to purchase the cabinets. Director Collins seconded the motion. All in favor, passed unanimously.

D. Discussion and possible action regarding: Identify the new primary admin for Intuit QuickBooks.

- Comptroller Kindleberger states that with the change of administration, there needs to be a new administrator for QuickBooks. She states that it should be Rebekah Bancroft who will now be the accounts payable representative.
 - Chairman Bryant motions to appoint Rebekah Elizabeth
 Bancroft the new Intuit QuickBooks administrator.
 Discussion: Clerk Bell asks Rebekah if she is up to the position. Rebekah responds with a yes. Director Bell seconded the motion. All in favor, passed unanimously.
