

**MINUTES OF THE REGULAR MEETING OF GOVERNING BOARD OF THE
NORTHERN ARIZONA FIRE DISTRICT
THURSDAY, SEPTEMBER 16, 2021**

The Governing Board of the Northern Arizona Fire District met this 16th day of September 2021, at 6:00 p.m. for its regular monthly meeting at the Fire Administration Building at 2600 E Northern Avenue, Kingman, Arizona.

1. **CALL TO ORDER** – The meeting was called to order by Chairman Bailey at 6:00 p.m.
2. **PLEDGE OF ALLEGIANCE** – Chairman Bailey led the Pledge of Allegiance.
3. **ROLL CALL OF BOARD MEMBERS** – Board members present: Chairman Jim Bailey, Director John Bryant, Director Sue Wilkin, Director Sue Brown, and Director Michael Collins.
4. **CALL TO THE PUBLIC** – The District may, but is not required to, give the public an opportunity to speak to any issue. A.R.S. §38-431.01(H) – No one spoke.
5. **APPROVAL OF MINUTES** – Director Collins moved to approve the Regular Meeting minutes of August 19, 2021, and the Executive Session minutes of August 19, 2021, as submitted. Director Wilkin seconded the motion. There were no questions or comments. Passed by unanimous decision. Motion carried.
