    efficient. He does not believe there is a fee for fires or for EMT calls. Amspoker stated that the
    fire district taxes takes up a larger percentage on his tax bill. He is wondering why the fire
    district added a fee of \$15 for burn permits when the cost of the equipment and the cost of the
    fuel and firefighter wages are already covered.
  - The assistant chief stated that burn permits are not something that is in the usual day to day things for the fire district so the cost is not something that is put into the budget fully when it comes to taxes. Every fire district around us are charging fees for burn permits and the district was holding off for as long as possible to help recover the cost in fuel. Amspoker stated that he wishes the board would reconsider, because he does not think that \$15 is going to hurt the budget that much.
