

# Privacy Policy

This Privacy Policy ("Policy") applies to <https://integrityassetrecovery.com/>, and Integrity Asset Recovery Inc. ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include <https://integrityassetrecovery.com/>. The Company's website is a services site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address

We do not collect any personal information about you unless you voluntarily provide it to us.
