***The NATP is required to have one-hundred (100) hours of clinical training under the immediate supervision of the Director of Staff Development (DSD)/Instructor. The training shall include demonstration by the Instructor or DSD of basic patient care skills based upon the theory and clinical instruction presented in the classroom. Return demonstrations by the student are also required and shall be under the immediate supervision (present when student is performing the skill) of the DSD or Instructor and shall be done in the clinical setting with patients/residents.

***Daily Nurse Assistant Training Program Schedule Breakdown (minimum 160 hours course and clinical work):

- 50 hours of didactics and theory in the classroom and 100 hours of supervised clinical training in a SNF or a long term facility
- Before the clinical training, the students require a minimum of 16 hours of didactics in the classroom
- Clinical Site Agreement with a SNF (validation period 2 years only with good standing with the Centers for Medicare and Medicaid Services, CMS) or a long term care clinical facility to provide the 100 hours of supervised clinical training for students; the clinical hours for students are between the hours of 6:00 a.m. to 8:00 p.m.
