#### **VOLUNTEER FIRE COMPANY EIT CREDIT**

Herman Volunteer Fire Company submitted their list of members that qualify for the Earned Income Tax Credit. The Township Secretary/Treasurer verified the individuals that submitted the Earned Income Tax Credit request were eligible.

#### **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 2. Salting of roads.
- 3. Equipment repaired.

A letter was sent Lockaton Junk Yard requesting not to park vehicles to close to the road. There has been no improvement. The Solicitor will be contacted regarding the next step for this matter.

# **ADDITIONAL BUSINESS**

The Planning Commission submitted their recommendation letter regarding Tony Gagliardi's property at 880 Herman Road for the installation of a road to access the back of the property for a borrow pit.

An informational meeting was held on January 6, 2020 with Rick Green, Willie Adams, and McLafferty Heating Cooling and Electrical, LLC regarding an issue with fumes and the ventilation system in the Township building. No decisions were made.

A request was submitted to the Township for a speed study on Mitchell Hill Road. The Township's Solicitor will be contacted regarding the requirements for a speed study.
