Willie Adams motioned to renew the Shuler Hardship Agreement at 3447 Beck Road for another year. Rick Green seconded the motion. Motion Carried Unanimously.

HEALTH INSURANCE & DENTAL INSURANCE RENEWAL

Willie Adams motioned to renew UPMC health insurance and Guardian dental insurance. Rick Green seconded the motion. Motion Carried Unanimously.

GENERAL FUND CD #64 and CD #100 RENEWAL

Larry Osche to motioned to renew General Fund CD #64 and CD #100 for three months. Willie Adams seconded the motion. Motion Carried Unanimously.

HERMAN VFC EARNED INCOME TAX CREDIT

Willie Adams motioned to approve for Robert P. Shuler, Jr. to receive the Herman Volunteer Fire Company Earned Income Tax Credit. It was confirmed that he is on the eligibility list. Rick Green seconded the motion. Motion Carried Unanimously.

Larry Osche motioned to submit to CoStars for 1,500 tons or road salt for the 2021 – 2022 contract. Rick Green seconded the motion. Motion Carried Unanimously.

ADDITIONAL BUSINESS

Willie Adams motioned for Roxann Stickney to design a postcard to notify residents that if they have been impacted by Covid-19 that Township has received funding through Community Development Block Grant CV-19 (CDBG CV-19) funding for mortgage, rent and utilities assistance. Rick Green seconded the motion. Motion Carried Unanimously.

Larry Osche motioned for a financial survey be conducted for Stutz Road and Binsey Road to establish eligibility for road improvements through the Community Development Block Grant (CDBG). Willie Adams seconded the motion. Motion Carried Unanimously.
