Rick Green motioned to approve the February 3, 2021 regularly scheduled public meeting minutes as presented. Larry Osche seconded the motion. Motion Carried Unanimously.

Due to the Summit Authority meeting cancellation, the invoice will be ratified at the next Authority meeting. Rick Green seconded the motion. Motion Carried Unanimously.

#### **SOLICITOR REPORT**

Solicitor, Michael Gallagher, presented the following report:

- 1. The Solicitor contacted Chris Ziegler of the Butler Freeport Community Trail to discuss the rails-to-trail Agreement for the public sewage service line. She had items that need addressed by the Township's engineer. The Solicitor will contact Rick Barnett from Senate Engineering Company regarding Ms. Ziegler's requests.
- 2. The process for the Carbon Center Road property clean-up court proceedings have begun.
- 3. The Gagliardi's Answers and Interrogatories have been submitted but are not complete and the verification signature was left blank. The Solicitor will contact the Gagliardi's attorney regarding these items.
- 4. Lockaton Junk Yard has made substantial progress with the vehicle clean-up. Work will commence on the fire lane beside the garage upon the repair of the equipment that is needed for this project.
- 5. Willie Adams motioned to proceed with the Portman Road property clean-up court proceedings. Rick Green seconded the motion. Motion Carried Unanimously.

### **BASE REPAIRS BID RESULTS**

### **CDBG-CV POST CARDS**

The Township has obtained Community Development Block Grant CV (CDBG-CV) for assistance with mortgage, rent and utilities for low-moderate income residents. Larry Osche seconded the motion. Rick Green voted "yes". Larry Osche voted "yes". Willie Adams voted "no". Motion Carried.
