# KARNS BRIDGE REPLACMENT ORDINANCE & BAMM COMPLIANCE

The Township engineer reviewed the Karns Bridge Replacement project and determined that the Planned Development for Chapter 102 Permits, stormwater management, municipal land use letter, and floodplain consistency met the Township's requirements.

## **RESOLUTION 2022-08 LOCAL SHARE ACCOUNT GRANT**

Rick Green motioned to authorize asphalt testing of Bonniebrook Road if an unsatisfactory resolution of the cracks in pavement occurs with Shields Asphalt Paving, Inc. Willie Adams seconded the motion. Motion Carried Unanimously.
