UCC APPEALS BOARD ORDINANCE & AGREEMENT

Willie Adams motioned to adopt Ordinance 81 the intergovernmental cooperative agreement for a multi-municipal uniform construction code board of appeals. Rick Green seconded the motion. Motion Carried Unanimously.

Willie Adams motioned for Summit Township to enter into a Building Code Board of Appeals Multi-Municipal Agreement. Rick Green seconded the motion. Motion Carried Unanimously.

COSTARS 2020-2021 SALT CONTRACT

Larry Osche motioned to authorize the Township's Secretary/Treasurer, Roxann Stickney, to submit the request for 1,500 tons of road salt for the 2020-2021 Costars contract. Rick Green seconded the motion. Motion Carried Unanimously.

BCATO SPRING CONVENTION

Willie Adams motioned for the Supervisors, Secretary/Treasurer, Planning Commission and Zoning Field Officer to attend the Spring Butler County Association of Township Officials convention on May 21, 2020. Rick Green seconded the motion. Motion Carried Unanimously.

SHEPPERD DRIVE

Chris Loder the property owner of 121 Shepperd Drive attended the meeting to discuss a water issue that is impacting the road. It was determined that the Roadmaster will submit a cost estimate for the project. Mr. Loder agreed to contribute to the project.

Rick Green motioned to add Shepperd Drive to the paving bid. Larry Osche seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Catch basins were cleaned and location documented.
- 2. Equipment maintenance was performed.
- 3. Potholes patched.
- 4. Roads were salted.

The Township has enough guide rails for Vogleyville Road. Green Acres Contracting Company, Inc. will be contacted for an installation estimate for the guiderails.

ADDITIONAL BUSINESS

Willie Adams announced that a meeting is scheduled with Senator Joe Pitman, Summit Authority and the Supervisors regarding the public sewage Act 537 Plan on March 5, 2020.

OPEN TO THE FLOOR – PUBLIC PARTICIPATION.

Roni Horstman thanked the Supervisors for the Dittmer Road project.

A resident brought to the Board of Supervisors attention that a property on Kaiser Road is accumulating junk, a possible business moving onto the property and mud on the road from vehicles exiting the property. A letter will be sent to the property owner regarding these issues.

The driveway at 880 Herman Road, Butler PA property that access Vetta Drive was discussed. It was determined that the barrier location need to be measured to ensure compliance with the driveway agreement.
