CALL TO ORDER

Willie Adams called the meeting to order at 6:45 p.m.

SUMMIT AUTHORITY PAYMENT REQUEST

The Supervisors reviewed the Summit Authority's payment request letter and Senate Engineering Company invoice 54794 for \$21,366.50 and Senate Engineering Company invoice 54894 for \$23,128.50. Both invoices were for the design phase of the Act 537 Sewage Plan for a total of \$44,495.00.

Rick Green motioned to approve Summit Authority's payment request for the above referenced invoices from Senate Engineering Company totaling \$44,495.00 for the design phase of the Act 537 Sewage Plan. Larry Osche seconded the motion. Motion Carried Unanimously.

SOLICITOR'S REPORT

The Solicitor requested that the signed Spinneweber Right-of-Way Agreement be submitted to him.

Upon the reviewing the findings of the Zoning Officer and Zoning Field Officer that there is not enough evidence of an individual allegedly living in a garage on McGrady Hollow Road to conclude that it is being occupied as a residence, Willie Adams motioned that the Township will not go out for six-months to the garage. The visit will only be conducted if the complainant places a deposit of one-hour wages for the Zoning Officer and Zoning Field Officer plus mileage to conduct a visit. If a violation is found, the deposit will be returned. If the complaint is unfounded, the Township will retain the deposit. Rick Green seconded the motion. Motion Carried Unanimously.

The Zoning Officer and Zoning Field Officer have been on multiple occasions to a property on McGrady Hollow Road for allegedly free ranging chickens. There has been no evidence of chickens free ranging. Larry Osche motioned that the Township will not go out for six-months for the chickens. The visit will only be conducted if the complainant places a deposit of one-hour wages for the Zoning Officer and Zoning Field Officer plus mileage to conduct a visit. If a violation is found, the deposit will be returned. If the complaint is unfounded, the Township will retain the deposit. Rick Green seconded the motion. Motion Carried Unanimously.

ANNUAL 2016 PETERBILT TRUCK PAYMENT

Larry Osche motioned to pay the annual 2016 Peterbilt truck payment of \$21,865.79 from the General Fund. Rick Green seconded the motion. Motion Carried Unanimously.

SPRING NEWSLETTER

Rick Green motioned to approve the publication of a Spring newsletter. It will be proofed by the Supervisors before being mailed. Larry Osche seconded the motion. Motion Carried Unanimously.

BCATO SPRING CONVENTION

Larry Osche motioned for the Supervisors, Secretary/Treasurer, Tax Collector, Auditors, Planning Commission members and Zoning Field Officer to attend the Butler County Association of Township Officials (BCATO) Spring Convention. Rick Green seconded the motion. Motion Carried Unanimously.

ENGINEER'S REPORT

Lot Line Revisions for Bergbigler and Shulik were reviewed and the recommendation letters were submitted to the Township.

GARAGE

Senate Engineering Company's proposal for engineering services for a garage was tabled until other options are researched.

BONNIEBROOK ROAD GRANT

Jefferson Township submitted information regarding a motion that was made on March 11, 2019 at their regular Public Meeting to approve the advertising of the Bonniebrook Road Multimodal Transportation Grant bid upon execution of the grant agreement.

It was determined that Summit Township will approve the advertising of the Bonniebrook Road Multimodal Transportation bid upon the execution of the Agreement and completion of the bid packet.

PAVING AND SEAL COAT BIDS

Rick Green motioned to advertise for bid the paving and seal coating of roads. Larry Osche seconded the motion. Motion Carried Unanimously.

ROLLER RENTAL

Roller rental quotes from Stephenson Equipment, Inc. and United Rentals were reviewed. United Rentals had the lowest quote amount.

Larry Osche motioned to rent a roller from United Rentals on the as needed basis. Rick Green seconded the motion. Motion Carried Unanimously.

JOHN DEERE BOOM MOWER

Larry Osche motioned to purchase the parts to repair of the spare boom mower deck for the John Deere tractor. Willie Adams seconded the motion. Motion Carried Unanimously.

FARMER'S DRIVEWAY

A farmer is putting dirt and mud on the Township's road from his tractor/equipment and it is causing a safety issue. It was determined that a letter will be sent to inform the farmer of the safety issue and for him to keep the road clear from dirt and mud.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Potholes patched.
- 2. Sweeping of roads.
- 3. Sign replacements.
- 4. Removal of winter equipment from the vehicles.

Dittmer Road has trees that are preventing the Township from repairing the road. The property owner will not grant the Township permission to remove the trees.

Section 2325 of the Commonwealth of Pennsylvania Second Class Township Codes states if trees constitute a danger to the highway they may be removed.

Rick Green motioned for the Township's Solicitor draft a Resolution for notice been given to the property owners on Dittmer Road that their trees are causing a hazard to the road and removal is necessary. Larry Osche seconded the motion. Motion Carried Unanimously.

ADDITIONAL BUSINESS

Larry Osche and Willie Adams reviewed the condition of Township Roads on March 20, 2019 at 1:00 p.m. and no decisions were made.

OPEN TO THE FLOOR – PUBLIC PARTICIPATION

There were no comments or questions from the floor.
