Rick Green motioned to approve the 2018-03 DCNR Playground Grant Resolution the Summit Elementary Playground renovation project. Larry Osche seconded the motion. Rick Green voted "yes". Larry Osche voted "yes". Willie Adams voted "no". Motion Carried

## **ZONING HEARING BOARD MEMBER & TOWNSHIP AUDITOR**

Willie Adams motioned to accept William Stevenson resignation from the Zoning Hearing Board and Felicia Kearns resignation as the Township's Auditor. Larry Osche seconded the motion. Motion Carried Unanimously.

## **VOLUNTEER EARNED INCOME TAX CREDIT**

Willie Adams motioned to approve the request for the Earned Income Tax Credit for a member of the Herman Volunteer Fire Company that met the requirements for the credit. Larry Osche seconded the motion. Motion Carried Unanimously

# **VALLEY VIEW DRIVE**

Larry Osche motioned to for the approval of \$81,000.00 for Valley View Drive to install stormwater inlets and pipe and pave and seal coat the road. Willie Adams seconded the motion. Motion Carried Unanimously.

# **BONNIE DRIVE POT HOLE**

Willie Adams motioned for the Roadmaster/Supervisor, Larry Osche, to contact PPC Lubricants regarding cost sharing the repair of the hole on Bonnie Drive. Rick Green seconded the motion. Motion Carried Unanimously.

## **BONNIE DRIVE TREES**

Willie Adams motioned for Roadmaster/Supervisor, Larry Osche, to contact Eagle Printery regarding the trimming of trees or paving of Bonnie Drive. Rick Green seconded the motion. Motion Carried Unanimously.

## **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 1. Piping on Fallecker Road is completed.
- 2. Piping on Binsey Road has started.
- 3. Patching of pot holes.
- 4. Working/repairing equipment.

Larry Osche sought quotes for the repair/replacement of dusk-dawn lights at the Route 38 and Route 68 intersection. Five companies were contacted, one company replied thus far. If the State approves the

repairs/replacement of the dusk-dawn lights, the final cost will be submitted to the State for 50% reimbursement of cost to the Township per our Highway Lighting Agreement from 2005.

The Carbon Center Road guide rail project is completed.

Peoples Gas must install a pipe on the water line side.

Larry Osche motioned for Rails-to-Trails to use the Township's parking lot on June 29, 2019. Willie Adams seconded the motion. Motion Carried Unanimously.

The Dirt, Gravel and Low Volume Grant Application for the third phase of Binsey Road has been submitted.

The Dirt, Gravel and Low Volume Grant Application for Old East Butler Road is being evaluated for grant approval.

## **ADDITIONAL BUSINESS**

Willie Adams motioned that an executive session was held on March 20, 2019 regarding zoning and March 29, 2019 regarding Bonnie Drive. No decisions were made.
