ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. The Township employees helped with tree trimming clean-up at Binsey Road. If funding is available, the Community Development Block Grant (CDBG) will reimburse the Township for the employees' wages.
- 2. Repairs to potholes and road berms were performed.
- 3. The Township's equipment was changed from winter to summer.
- 4. The replacement light pole order was approved in the above referenced invoice section. Upon Central Electric receiving payment, installation will be scheduled.
- 5. The 2013 Ford F-550 brakes were repaired.
- 6. Roads were checked.
